



#### **BONDS**

#### **Supply Bond**

Seller shall furnish Buyer a supply bond in the amount of at least 5% of the Contract Price, as security for the faithful and timely delivery of all procured items covered by this procurement agreement. The bond shall remain in effect until 1) inspection by Buyer or satisfaction of delivery based on visual inspection, or 2) twenty days after receipt of all procured items, whichever is later.

#### **CONTRACTORS INSURANCE**

- 1. The Contractor shall not commence any work in connection with this Agreement until he has obtained all required insurance and such insurance has been approved by the Okaloosa County Risk Manager or designee.
- 2. All insurance policies shall be with insurers authorized to do business in the State of Florida.
- 3. All insurance shall include the interest of all entities named and their respective officials, employees & volunteers of each and all other interests as may be reasonably required by Okaloosa County. The coverage afforded the Additional Insured under this policy shall be primary insurance. If the Additional Insured have other insurance that is applicable to the loss, such other insurance shall be on an excess or contingent basis. The amount of the company's liability under this policy shall not be reduced by the existence of such other insurance.
- 4. Where applicable, the County shall be shown as an Additional Insured with a Waiver of Subrogation on the Certificate of Insurance.
- 5. The County shall retain the right to reject all insurance policies that do not meet the requirement of this Agreement. Further, the County reserves the right to change these insurance requirements with 60-day notice to the Contractor.
- 6. The County reserves the right at any time to require the Contractor to provide copies (redacted if necessary) of any insurance policies to document the insurance coverage specified in this Agreement.
- 7. The designation of Contractor shall include any associated or subsidiary company which is involved and is a part of the contract and such, if any associated or subsidiary company involved in the project must be named in the Workers' Compensation coverage.
- 8. Any exclusions or provisions in the insurance maintained by the Contractor that excludes coverage for work contemplated in this agreement shall be deemed unacceptable and shall be considered breach of contract.

#### WORKERS' COMPENSATION INSURANCE

- 1. The Contractor shall secure and maintain during the life of this Agreement Workers' Compensation insurance for all of his employees employed for the project or any site connected with the work, including supervision, administration or management, of this project and in case any work is sublet, with the approval of the County, the Contractor shall require the Subcontractor similarly to provide Workers' Compensation insurance for all employees employed at the site of the project, and such evidence of insurance shall be furnished to the County not less than ten (10) days prior to the commencement of any and all sub-contractual Agreements which have been approved by the County.
- 2. Contractor must be in compliance with all applicable State and Federal workers' compensation laws, including the U.S. Longshore Harbor Workers' Act or Jones Act, if applicable.
- **3.** No class of employee, including the Contractor himself, shall be excluded from the Workers' Compensation insurance coverage. The Workers' Compensation insurance shall also include Employer's Liability coverage.

#### BUSINESS AUTOMOBILE LIABILITY

Coverage must be afforded for all Owned, Hired, Scheduled, and Non-Owned vehicles for Bodily Injury and Property Damage in an amount not less than \$1,000,000 combined single limit each accident. If the contractor does not own vehicles, the contractor shall maintain coverage for Hired & Non-Owned Auto Liability, which may be satisfied by way of endorsement to the Commercial General Liability policy or separate Business Auto Policy. Contractor must maintain this insurance coverage throughout the life of this Agreement.

#### COMMERCIAL GENERAL LIABILITY INSURANCE

- 1. The Contractor shall carry other Commercial General Liability insurance against all other Bodily Injury, Property Damage and Personal and Advertising Injury exposures.
- 2. All liability insurance (other than Professional Liability) shall be written on an occurrence basis and shall not be written on a claims-made basis. If the insurance is issued with an aggregate limit of liability, the aggregate limit of liability shall apply only to the locations included in this Agreement. If, as the result of any claims or other reasons, the available limits of insurance reduce to less than those stated in the Limits of Liability, the Contractor shall notify the County representative in writing. The Contractor shall purchase additional liability insurance to maintain the requirements established in this Agreement. Umbrella or Excess Liability insurance can be purchased to meet the Limits of Liability specified in this Agreement.
- **3.** Commercial General Liability coverage shall include the following:
  - 1.) Premises & Operations Liability
  - 2.) Bodily Injury and Property Damage Liability
  - 3.) Independent Contractors Liability
  - 4.) Contractual Liability
  - 5.) Products and Completed Operations Liability
- **4**. Contractor shall agree to keep in continuous force Commercial General Liability coverage for the length of the contract.

#### **LIMITS OF LIABILITY**

#### NOTICE OF CLAIMS OR LITIGATION

The County representative shall receive written notice in the form of a detailed written report describing the incident or claim within ten (10) days of the Contractor's knowledge. In the event such incident or claim involves injury and/or property damage to a third party, verbal notification shall be given the same day the Contractor becomes aware of the incident or claim followed by a written detailed report within ten (10) days of verbal notification.

#### INDEMNIFICATION & HOLD HARMLESS

Contractor shall indemnify and hold harmless the County, its officers and employees from liabilities, damages, losses, and costs including but not limited to reasonable attorney fees, to the extent caused by the negligence, recklessness, or wrongful conduct of the Contractor and other persons employed or utilized by the Contractor in the performance of this contract.

Note: For Contractor's convenience, this certification form is enclosed and is made a part of the bid package.

#### CERTIFICATE OF INSURANCE

- 1. Certificates of insurance indicating the job site and evidencing all required coverage must be submitted not less than 10 days prior to the commencement of any of the work. The certificate holder(s) shall be as follows: Okaloosa County, 5479A Old Bethel Road, Crestview, Florida, 32536.
- 2. The contractor shall provide a Certificate of Insurance to the County with a thirty (30) day notice of cancellation; ten (10 days' notice if cancellation is for nonpayment of premium).
- 3. In the event that the insurer is unable to accommodate the cancellation notice requirement, it shall be the responsibility of the contractor to provide the proper notice. Such notification shall be in writing

by registered mail, return receipt requested, and addressed to the Okaloosa County Purchasing Department at 5479-A Old Bethel Road, Crestview, FL 32536.

- 4. In the event the contract term goes beyond the expiration date of the insurance policy, the contractor shall provide the County with an updated Certificate of insurance no later than ten (10) days prior to the expiration of the insurance currently in effect. The County reserves the right to suspend the contract until this requirement is met.
- 5. The certificate shall indicate if coverage is provided under a claims-made or occurrence form. If any coverage is provided on a claims-made form, the certificate will show a retroactive date, which should be the same date of the initial contract or prior.
- 6. All certificates shall be subject to Okaloosa County's approval of adequacy of protection and the satisfactory character of the Insurer.
- 7. All deductibles or SIRs, whether approved by Okaloosa County or not, shall be the Contractor's full responsibility. In particular, the Contractor shall afford full coverage as specified herein to entities listed as Additional Insured.
- 8. In no way will the entities listed as Additional Insured be responsible for, pay for, be damaged by, or limited to coverage required by this schedule due to the existence of a deductible or SIR.

#### GENERAL TERMS

Any type of insurance or increase of limits of liability not described above which, the Contractor required for its own protection or on account of statute shall be its own responsibility and at its own expense.

Any exclusions or provisions in the insurance maintained by the contractor that excludes coverage for work contemplated in this contract shall be deemed unacceptable and shall be considered breach of contract.

The carrying of the insurance described shall in no way be interpreted as relieving the Contractor of any responsibility under this contract.

Should the Contractor engage a subcontractor or sub-subcontractor, the same conditions will apply under this Agreement to each subcontractor and sub-subcontractor.

The Contractor hereby waives all rights of subrogation against Okaloosa County and its consultants and other indemnities of the Contractor under all the foregoing policies of insurance.

#### **UMBRELLA INSURANCE**

The Contractor shall have the right to meet the liability insurance requirements with the purchase of an umbrella insurance policy. In all instances, the combination of primary and umbrella liability coverage must equal or exceed the minimum liability insurance limits stated in this Agreement.

### GENERAL SERVICES BID CONDITIONS

#### 1. PRE-BID ACTIVITY -

**Addendum -** Except as provided in this section, respondents are prohibited from contacting or lobbying the County, County Administrator, Commissioners, County staff, and Review Committee members, or any other person authorized on behalf of the County related or involved with the solicitation. All inquiries on the scope of work, specifications, additional requirements, attachments, terms and general conditions or instructions, or any issue must be directed in writing, by US mail or email to:

All questions or inquiries must be received no later than the last day for questions (reference ITB & Respondent's Acknowledgement form). Any addenda or other modification to the bid documents will be issued by the County five (5) days prior to the date and time of bid closing, as written addenda, and will be posted to <a href="http://www.bidnetdirect.com/florida">http://www.bidnetdirect.com/florida</a> and the Okaloosa County website at <a href="http://www.co.okaloosa.fl.us/purchasing/current-solicitations">http://www.co.okaloosa.fl.us/purchasing/current-solicitations</a>.

Such written addenda or modification shall be part of the bid documents and shall be binding upon each respondent. Each respondent is required to acknowledge receipt of any and all addenda in writing and submit with their bid. No respondent may rely upon any verbal modification or interpretation.

**2. PREPARATION OF BID** – The bid form is included with the bid documents. Additional copies may be obtained from the County. The respondent shall submit an original and two (2) copies {total three (3)} of the bid documents.

All blanks in the bid documents shall be completed by printing in ink or by typewriter in both words and numbers with the amounts extended, totaled and the bid signed. A bid price shall be indicated for each section, bid item, alternative, adjustment unit price item, and unit price item listed therein, or the words "No Bid", "No Change", or "Not Applicable" entered. No changes shall be made to the phraseology of the form or in the items mentioned therein. In case of any discrepancy between the written amount and the numerical figures, the written amount shall govern. Any bid which contains any omissions, erasures, alterations, additions, irregularities of any kind, or items not called for which shall in any manner fail to conform to the conditions of public notice inviting bids may be rejected.

A bid submitted by a partnership shall be executed in the partnership name and signed by a partner (whose title must appear under the signature). The official address of the partnership shall be shown below the signature.

A bid submitted by a limited liability company shall be executed in the name of the firm by a member and accompanied by evidence of authority to sign. The state of formation of the firm and the official address of the firm must be shown below the signature.

A bid submitted by an individual shall show the respondent's name and official address.

A bid submitted by a joint venture shall be executed by each joint venture in the manner indicated on the bid form. The official address of the joint venture must be shown below the signature.

It is preferred that all signatures be in <u>blue ink</u> with the names type or printed below the signature. Okaloosa County does not accept electronic signatures.

The bid shall contain an acknowledgement of receipt of all Addenda, the numbers of which shall be filled in on the form. The address and telephone # for communications regarding the bid shall be shown.

If the respondent is an out-of-state corporation, the bid shall contain evidence of respondent's authority and qualification to do business as an out-of-state corporation in the State of Florida in accordance with Article 3. A state contractor license # for the State of Florida shall also be included on the bid form. Respondent shall be licensed in accordance with the requirements of Chapter 489, Florida Statutes.

- 3. INTEGRITY OF BID DOCUMENTS Respondents shall use the original Bid documents provided by the Purchasing Department and enter information only in the spaces where a response is requested. Respondents may use an attachment as an addendum to the Bid documents if sufficient space is not available. Any modifications or alterations to the original bid documents by the respondent, whether intentional or otherwise, will constitute grounds for rejection of a bid. Any such modification or alteration that a respondent wishes to propose must be clearly stated in the respondent's response in the form of an addendum to the original bid documents.
- **4. SUBMITTAL OF BID** A bid shall be submitted no later than the date and time prescribed and at the place indicated in the advertisement or invitation to bid and shall be enclosed in an opaque sealed envelope plainly marked with the project title (and, if applicable, the designated portion of the project for which the bid is submitted), the name and address of the respondent, and shall be accompanied by the bid security and other required documents. It is the respondent's responsibility to assure that its bid is delivered at the proper time and place. Offers by telegram, facsimile, or telephone will **NOT** be accepted.

Note: Crestview is <u>not</u> a next day delivery site for overnight carriers.

5. MODIFICATION & WITHDRAWAL OF BID - A bid may be modified or withdrawn by an appropriate document duly executed in the manner that a bid must be executed and delivered to the place where bids are to be submitted prior to the date and time for the opening of bids.

If within 24 hours after bids are opened any respondent files a duly signed written notice with the County and promptly thereafter demonstrates to the reasonable satisfaction of the County that there was a material substantial mistake in the preparation of its bid, that respondent may withdraw its bid, and the bid security may be returned. Thereafter, if the work is rebid, that respondent will be disqualified from 1) further bidding on the work, and 2) doing any work on the contract, either as a subcontractor or in any other capacity.

- **6. BIDS TO REMAIN SUBJECT TO ACCEPTANCE** All bids will remain subject to acceptance or rejection for ninety (90) calendar days after the day of the bid opening, but the County may, in its sole discretion, release any bid and return the bid security prior to the end of this period.
- **7. IDENTICAL TIE BIDS** In case of identical procurement responses, the award shall be determined either by lot or on the basis of factors deemed to serve the interest of the County. In the case of the latter, there must be adequate documentation to support such a decision.
- **8. CONDITIONAL & INCOMPLETE BIDS** Okaloosa County specifically reserves the right to reject any conditional bid and bids which make it impossible to determine the true amount of the bid.
- **9. BID PRICE** The bid price shall include all equipment, labor, materials, permit(s), freight, taxes, required insurance, Public Liability, Property Damage and Workers' Compensation, etc. to cover the finished work called for.
- **10. ADDITION/DELETION OF ITEM** The County reserves the right to add or delete any item from this bid or resulting contract when deemed to be in the County's best interest.
- 11. SPECIFICATION EXCEPTIONS Specifications are based on the most current literature available. Respondent shall clearly list any change in the manufacturer's specifications which conflict with the bid specifications. Respondent must also explain any deviation from the bid specification in writing, as a foot note on the applicable bid page and enclose a copy of the manufacturer's specifications data detailing the changed item(s) with their bid. Failure of the respondent to comply with these provisions will result in respondents being held responsible for all costs required to bring the equipment in compliance with bid specifications.
- **12. APPLICABLE LAWS & REGULATIONS** All applicable Federal and State laws, County and municipal ordinances, orders, rules and regulations of all authorities having jurisdiction over the project shall apply to the bid throughout, and they will be deemed to be included in the contract the same as though they were written in full therein.
- **13. DISQUALIFICATION OF RESPONDENTS** Any of the following reasons may be considered as sufficient for the disqualification of a respondent and the rejection of its bid:
  - a. Submission of more than one bid for the same work from an individual, firm or corporation under the same or different name.
  - b. Evidence that the respondent has a financial interest in the firm of another respondent for the same work.
  - c. Evidence of collusion among respondents. Participants in such collusion will receive no recognition as respondents for any future work of the County until such participant has been reinstated as a qualified respondent.
  - d. Uncompleted work which in the judgment of the County might hinder or prevent the prompt completion of additional work if awarded.
  - e. Failure to pay or satisfactorily settle all bills due for labor and material on former contracts in force at the time of advertisement of bids.

- f. Default under previous contract.
- g. Listing of the respondent by the Local, State or Federal Government on its barred/suspended vendor list.

#### 14. AWARD OF BID

- **a.** Okaloosa County Review Okaloosa County designated Staff will review all bids and will participate in the Recommendation to Award.
- b. The County will award the bid to the lowest respondent, and the County reserves the right to award the bid to the respondent submitting a responsive bid with a resulting negotiated agreement which is most advantageous and in the best interest of the County, and to reject any and all bids or to waive any irregularity or technicality in bids received. Okaloosa County shall be the sole judge of the bid and the resulting negotiated agreement that is in its best interest and its decision shall be final.
- c. Okaloosa County reserves the right to waive any informalities or reject any and all bids, in whole or part, to utilize any applicable state contracts in lieu of or in addition to this bid and to accept the bid that in its judgment will best serve the interest of the County.
- d. Okaloosa County specifically reserves the right to reject any conditional bids and will normally reject those which made it impossible to determine the true amount of the bid. Each item must be bid separately and no attempt is to be made to tie any item or items to any other item or items.
- **15. WARRANTY** (The warranty will be in the name of Okaloosa County) Warranty work specified herein is for defects in materials and in labor and workmanship. State the manufacturer's warranty with your bid. A minimum of 1 year on parts and labor is required from the date of acceptance, or the manufacturer's warranty, whichever is longer.
- **16. PAYMENTS** The respondent shall be paid upon submission of invoices and approval of acceptance by Okaloosa County Board of County Commissioners, Finance Office, 302 N. Wilson St., #203, Crestview FL 32536, for the prices stipulated herein for articles delivered and accepted. Invoices must show Contract #.
- **17. DISCRIMINATION** An entity or affiliate who has been placed on the discriminatory vendor list may not submit a bid on a contract to provide goods or services to a public entity, may not submit a bid on a contract with a public entity for the construction or repair of a public building or public work, may not submit bids on leases of real property to a public entity, may not award or perform work as a contractor, supplier, subcontractor, or consultant under contract with any public entity, and may not transact business with any public entity.
- **18. ### PART 1 - GENERAL

#### I wi

## 1.1 DESCRIPTION

- A. The submittal of Shop Drawings shall conform to requirements in this Section. A separate transmittal form shall be used for each specific item or class of material or equipment for which a submittal is required.
- B. The term "Shop Drawings" as used herein shall be understood to include detailed design calculations, fabrication and installation drawings, lists, graphs, test data, operating instructions, and other items which shall include, but are not necessarily limited to:
  - 1. Drawings and catalog information and cuts.
  - 2. Specifications, parts list, suggested spare parts lists, and equipment drawings.
  - 3. Wiring diagrams of systems and equipment.
  - 4. Complete lubrication, maintenance and operation instructions, including initial startup instructions.
  - 5. Applicable certifications.
  - 6. Anchor bolt templates, mounting instructions, and mounting design calculations as required.
  - 7. Required maintenance operations to allow all installed equipment to remain idle for a period of time not to exceed 24 months.
  - 8. Other technical, installation, and maintenance data as applicable.
  - 9. Unloading and handling methods and storage requirements.
  - 10. Note, highlight, and explain proposed changes to the Contract Documents.
  - 11. Paint submittal showing type of paint and the mils thickness of coating system used.
  - 12. Drawings showing Installation Contractor field verifications illustrating all field dimensions. Installation Contractor shall field verify all dimensions and existing materials shown on the Drawings. Any modifications required shall be at Installation Contractor's expense.

### 1.2 PROCEDURE

- A. Submit Shop Drawings to ENGINEER.
- B. A letter of transmittal shall accompany each submittal. If data for more than one Section of the Specifications is submitted, a separate transmittal letter shall accompany the data submitted for each Section.
- C. All letters of transmittal shall be submitted in duplicate.

G.	All Shop Drawings submitted shall bear the stamp of approval and signature of SUPPLIER as evidence that they have been reviewed and verified to the completeness of the submittal by SUPPLIER. Submittal without this stamp of approval will not be reviewed by ENGINEER and will be returned to SUPPLIER. SUPPLIER's stamp shall contain the following minimum information:

H. SUPPLIER shall utilize the submittal identification numbering system as follows:

1. The Submittal Number shall be a separate and unique number correlating to each individual submittal that is required to be tracked as a separate and unique item. The Submittal Number shall be a two-part, eight-character, alpha/numeric number assigned by SUPPLIER in the following manner:

- a. The first part of the Submittal Number shall consist of five characters that pertain to the applicable Specification Section number.
- b. The second part of the Submittal Number shall consist of three digits (numbers 001 to 999) to number each separate and unique submittal submitted under each Specification Section.
- c. A dash shall separate the two parts of the Submittal Number.
- d. A typical Submittal Number for the third Working Drawing submitted under Section 15101, Ductile Iron Pipe, would be 15101-003.
- 2. The Review Cycle shall be a three-digit number indicating the initial submission or resubmission of the same submittal. For example:
  - 001 = First (initial) submission.
  - 002 = Second submission (first resubmission).
  - 003 = Third submission (second resubmission).
- 3. An example of the typical submittal identification numbers for the first submission of the third submittal submitted under Section 15051, Buried Piping Installation is:

- I. SUPPLIER shall initially submit to ENGINEER a minimum of five copies of all submittals that are on 11-inch by 17-inch or smaller sheets, and one unfolded reproducible and three prints made from that reproducible for all submittal on sheets larger than 11-inch by 17-inch.
- J. After ENGINEER completes his review, Shop Drawings will be affixed with a stamp and marked with one of the following notations:
  - 1. Approved.
  - 2. Approved as Corrected.
  - 3. Approved as Corrected, Resubmit.
  - 4. Revise and Resubmit.
  - 5. Not Approved.
  - 6. Not Reviewed.
  - 7. For Information Only.

- K. If a submittal is acceptable, it will be marked "Approved" or "Approved as Corrected." Three prints or copies of the submittal will be returned to SUPPLIER.
- L. Upon return of a submittal marked "Approved" or "Approved as Corrected," SUPPLIER may order, ship or fabricate the materials included on the submittal, provided it is in accordance with the corrections indicated.
- M. If a Shop Drawing marked "Approved as Corrected" has extensive corrections or corrections affecting other Shop Drawings or Work, ENGINEER may require that SUPPLIER make the corrections indicated thereon and resubmit the Shop Drawings for record purposes. Such Shop Drawings will have the notation, "Approved as Corrected Resubmit." The corrected Shop Drawing shall be a pre-condition for payment for the work item of the Shop Drawing.
- N. If a submittal is unacceptable, two copies will be returned to SUPPLIER with one of the following notations:
  - 1. "Revise and Resubmit."
  - 2. "Not Approved."
- O. Upon return of a submittal marked "Revise and Resubmit", SUPPLIER shall make the corrections indicated and repeat the initial approval procedure. The "Not Approved" notation is used to indicate material or equipment that is not acceptable. Upon return of a submittal so marked, SUPPLIER shall repeat the initial approval procedure utilizing acceptable material or equipment.
- P. Shop Drawings shall be submitted well in advance of the need for the material or equipment for construction and with ample allowance for the time required to make delivery of material or equipment after data covering such is approved. SUPPLIER and Installation Contractor shall assume the risk for all Work, materials or equipment that are fabricated, delivered or installed prior to the approval of Shop Drawings. Materials or equipment will not be included in periodic progress payments until approval thereof has been obtained in the specified manner.
- Q. ENGINEER will review and process all submittals promptly; a reasonable time shall be allowed for this, for the Shop Drawings being revised and resubmitted, and for time required to return the approved Shop Drawings to SUPPLIER.
- R. SUPPLIER shall furnish required submittals with complete information and accuracy in order to achieve required approval of an item within two submittals.
- S. Mark each page of a submittal and each individual component submitted with the specification number, paragraph, and subparagraph. Arrange submittal information presentation to appear in the sequence in the Specification Section.

## SECTION 01400 QUALITY REQUIREMENTS

## **PART 1 - GENERAL**

### 1.1 SUMMARY

- A. This Section includes administrative and procedural requirements for quality assurance and quality control.
- B. Testing and inspecting services are required to verify compliance with requirements specified or indicated. These services do not relieve SUPPLIER of responsibility for compliance with the Contract Document requirements.
  - 1. Specified tests, inspections, and related actions do not limit SUPPLIER's other quality-assurance and -control procedures that facilitate compliance with the Contract Document requirements.
  - 2. Requirements for SUPPLIER to provide quality-assurance and -control services required by ENGINEER, OWNER, or authorities having jurisdiction are not limited by provisions of this Section.
- C. See Divisions 2 through 16 Sections for specific test and inspection requirements.

### 1.2 DEFINITIONS

- A. Quality-Assurance Services: Activities, actions, and procedures performed before and during execution of the Work to guard against defects and deficiencies and substantiate that proposed construction will comply with requirements.
- B. Quality-Control Services: Tests, inspections, procedures, and related actions during and after execution of the Work to evaluate that actual products incorporated into the Work and completed construction comply with requirements. Services do not include contract enforcement activities performed by ENGINEER.
- C. Mockups: Full-size, physical assemblies that are constructed on-site. Mockups are sed to verify selections made under sample submittals, to demonstrate aesthetic effects and, where indicated, qualities of materials and execution, and to review construction, coordination, testing, or operation; they are not Samples. Approved mockups establish the standard by which the Work will be judged.
- D. Laboratory Mockups: Full-size, physical assemblies that are constructed at testing facility to verify performance characteristics.
- E. Preconstruction Testing: Tests and inspections that are performed specifically for the Project before products and materials are incorporated into the Work to verify performance or compliance with specified criteria.

- F. Product Testing: Tests and inspections that are performed by an NRTL, an NVLAP, or a testing agency qualified to conduct product testing and acceptable to authorities having jurisdiction, to establish product performance and compliance with industry standards.
- G. Source Quality-Control Testing: Tests and inspections that are performed at the source, i.e., plant, mill, factory, or shop.
- H. Field Quality-Control Testing: Tests and inspections that are performed on-site for installation of the Work and for completed Work.
- I. Testing Agency: An entity engaged to perform specific tests, inspections, or both. Testing laboratory shall mean the same as testing agency.
- J. Installer/Applicator/Erector: CONTRACTOR or another entity engaged by CONTRACTOR as an employee, Subcontractor, or Sub-subcontractor, to perform a particular construction operation, including installation, erection, application, and similar operations.
  - 1. Using a term such as "carpentry" does not imply that certain construction activities must be performed by accredited or unionized individuals of a corresponding generic name, such as "carpenter." It also does not imply that requirements specified apply exclusively to trades people of the corresponding generic name.
- K. Experienced: When used with an entity, "experienced" means having successfully completed a minimum of five previous projects similar in size and scope to this Project; being familiar with special requirements indicated; and having complied with requirements of authorities having jurisdiction.

## 1.3 CONFLICTING REQUIREMENTS

- A. General: If compliance with two or more standards is specified and the standards establish different or conflicting requirements for minimum quantities or quality levels, comply with the most stringent requirement. Refer uncertainties and requirements that are different, but apparently equal, to ENGINEER for a decision before proceeding.
- B. Minimum Quantity or Quality Levels: The quantity or quality level shown or specified shall be the minimum provided or performed. The actual installation may comply exactly with the minimum quantity or quality specified, or it may exceed the minimum within reasonable limits. To comply with these requirements, indicated numeric values are minimum or maximum, as appropriate, for the context of requirements. Refer uncertainties to ENGINEER for a decision before proceeding.

### 1.4 SUBMITTALS

- A. Qualification Data: For testing agencies specified in "Quality Assurance" Article to demonstrate their capabilities and experience. Include proof of qualifications in the form of a recent report on the inspection of the testing agency by a recognized authority.
- B. Reports: Prepare and submit certified written reports that include the following:
  - 1. Date of issue.
  - 2. Project title and number.
  - 3. Name, address, and telephone number of testing agency.
  - 4. Dates and locations of samples and tests or inspections.
  - 5. Names of individuals making tests and inspections.
  - 6. Description of the Work and test and inspection method.
  - 7. Identification of product and Specification Section.
  - 8. Complete test or inspection data.
  - 9. Test and inspection results and an interpretation of test results.
  - 10. Record of temperature and weather conditions at time of sample taking and testing and inspecting.
  - 11. Comments or professional opinion on whether tested or inspected Work complies with the Contract Document requirements.
  - 12. Name and signature of laboratory inspector.
  - 13. Recommendations on retesting and reinspecting.
- C. Permits, Licenses, and Certificates: For OWNER's records, submit copies of permits, licenses, certifications, inspection reports, releases, jurisdictional settlements, notices, receipts for fee payments, judgments, correspondence, records, and similar documents, established for compliance with standards and regulations bearing on performance of the Work.

## 1.5 QUALITY ASSURANCE

- A. General: Qualifications paragraphs in this Article establish the minimum qualification levels required; individual Specification Sections specify additional requirements.
- B. Installer Qualifications: A firm or individual experienced in installing, erecting, or assembling work similar in material, design, and extent to that indicated for this Project, whose work has resulted in construction with a record of successful in-service performance.
- C. SUPPLIER Qualifications: A firm experienced in manufacturing products or systems similar to those indicated for this Project and with a record of successful in-service performance, as well as sufficient production capacity to produce required units.

- D. Fabricator Qualifications: A firm experienced in producing products similar to those indicated for this Project and with a record of successful in-service performance, as well as sufficient production capacity to produce required units.
- E. Professional Engineer Qualifications: A professional engineer who is legally qualified to practice in jurisdiction where Project is located and who is experienced in providing engineering services of the kind indicated. Engineering services are defined as those performed for installations of the system, assembly, or product that is similar to those indicated for this Project in material, design, and extent.
- F. Specialists: Certain sections of the Specifications require that specific construction activities shall be performed by entities who are recognized experts in those operations. Specialists shall satisfy qualification requirements indicated and shall be engaged for the activities indicated.
  - 1. Requirement for specialists shall not supersede building codes and regulations governing the Work.
- G. Testing Agency Qualifications: An NRTL, an NVLAP, or an independent agency with the experience and capability to conduct testing and inspecting indicated, as documented according to ASTM E 548; and with additional qualifications specified in individual Sections; and where required by authorities having jurisdiction, that is acceptable to authorities.
  - 1. NRTL: A nationally recognized testing laboratory according to 29 CFR 1910.7.
  - 2. NVLAP: A testing agency accredited according to NIST's National Voluntary Laboratory Accreditation Program.
- H. Factory-Authorized Service Representative Qualifications: An authorized representative of manufacturer who is trained and approved by manufacturer to inspect installation of manufacturer's products that are similar in material, design, and extent to those indicated for this Project.
- I. Mockups: Before installing portions of the Work requiring mockups, build mockups for each form of construction and finish required to comply with the following requirements, using materials indicated for the completed Work:
  - 1. Build mockups in location and of size indicated or, if not indicated, as directed by ENGINEER.
  - 2. Notify ENGINEER seven days in advance of dates and times when mockups will be constructed.
  - 3. Demonstrate the proposed range of aesthetic effects and workmanship.
  - 4. Obtain ENGINEER's approval of mockups before starting work, fabrication, or construction.
  - 5. Maintain mockups during construction in an undisturbed condition as a standard for judging the completed Work.
  - 6. Demolish and remove mockups when directed, unless otherwise indicated.

J. Laboratory Mockups: Comply with requirements of preconstruction testing and those specified in individual Sections in Divisions 2 through 16.

## 1.6 QUALITY CONTROL

- A. OWNER Responsibilities: Where quality-control services are indicated as OWNER's responsibility, OWNER will engage a qualified testing agency to perform these services.
  - 1. OWNER will furnish CONTRACTOR with names, addresses, and telephone numbers of testing agencies engaged and a description of types of testing and inspecting they are engaged to perform.
  - 2. Costs for retesting and re-inspecting construction that replaces or is necessitated by work that failed to comply with the Contract Documents will be charged to CONTRACTOR, and the Contract Sum will be adjusted by Change Order.
- B. Tests and inspections not explicitly assigned to OWNER are CONTRACTOR's responsibility. Unless otherwise indicated, provide quality-control services specified and those required by authorities having jurisdiction. Perform quality-control services required of CONTRACTOR by authorities having jurisdiction, whether specified or not.
  - 1. Where services are indicated as CONTRACTOR's responsibility, engage a qualified testing agency to perform these quality-control services.
    - a. CONTRACTOR shall not employ same entity engaged by OWNER, unless agreed to in writing by OWNER.
  - 2. Notify testing agencies at least 24 hours in advance of time when Work that requires testing or inspecting will be performed.
  - 3. Where quality-control services are indicated as CONTRACTOR's responsibility, submit a certified written report, in duplicate, of each quality-control service.
  - 4. Testing and inspecting requested by CONTRACTOR and not required by the Contract Documents are CONTRACTOR's responsibility.
  - 5. Submit additional copies of each written report directly to authorities having jurisdiction, when they so direct.
- C. SUPPLIER's Field Services: Where indicated, engage a factory-authorized service representative to inspect field-assembled components and equipment installation, including service connections. Report results in writing as specified in Division 1 Section "Submittal Procedures."
- D. Retesting/Re-inspecting: Regardless of whether original tests or inspections were Contractor's responsibility, provide quality-control services, including retesting and re- inspecting, for construction that replaced Work that failed to comply with the Contract Documents.

- E. Testing Agency Responsibilities: Cooperate with ENGINEER and CONTRACTOR in performance of duties. Provide qualified personnel to perform required tests and inspections.
  - 1. Notify ENGINEER and CONTRACTOR promptly of irregularities or deficiencies observed in the Work during performance of its services.
  - 2. Determine the location from which test samples will be taken and in which insitu tests are conducted.
  - 3. Conduct and interpret tests and inspections and state in each report whether tested and inspected work complies with or deviates from requirements.
  - 4. Submit a certified written report, in duplicate, of each test, inspection, and similar quality-control service through CONTRACTOR.
  - 5. Do not release, revoke, alter, or increase the Contract Document requirements or approve or accept any portion of the Work.
  - 6. Do not perform any duties of CONTRACTOR.
- F. Associated Services: Cooperate with agencies performing required tests, inspections, and similar quality-control services, and provide reasonable auxiliary services as requested. Notify agency sufficiently in advance of operations to permit assignment of personnel. Provide the following:
  - 1. Access to the Work.
  - 2. Incidental labor and facilities necessary to facilitate tests and inspections.
  - 3. Adequate quantities of representative samples of materials that require testing and inspecting. Assist agency in obtaining samples.
  - 4. Facilities for storage and field curing of test samples.
  - 5. Delivery of samples to testing agencies.
  - 6. Preliminary design mix proposed for use for material mixes that require control by testing agency.
  - 7. Security and protection for samples and for testing and inspecting equipment at Project site.
- G. Coordination: Coordinate sequence of activities to accommodate required quality-assurance and -control services with a minimum of delay and to avoid necessity of removing and replacing construction to accommodate testing and inspecting.
  - 1. Schedule times for tests, inspections, obtaining samples, and similar activities.

- A. General: On completion of testing, inspecting, sample taking, and similar services, repair damaged construction and restore substrates and finishes.

- C. Repair and protection are CONTRACTOR's responsibility, regardless of the assignment of responsibility for quality-control services.

## SECTION 01630 SUBSTITUTION PROCEDURES

## PART 1 - GENERAL

## 1.1 PROCEDURE FOR REQUESTING SUBSTITUTION:

- A. In order that the Owner may determine if a proposed, unnamed substitute item shall be allowed for the specified and named equipment/supplier, the information below shall be SUBMITTED A MINIMUM 10 DAYS PRIOR TO PROPOSAL BID DATE.
- B. Written requests must be submitted to the Engineer.
- C. Transmittal Contents:
  - 1. Product identification:
    - a. Manufacturer's name.
    - b. Telephone number and representative contact name.
    - c. Specification section or drawing reference of originally specified product, including discrete name or tag number assigned to original product in the Contract Documents.
  - 2. Manufacturer's literature clearly marked to show compliance of proposed product with Contract Documents.
  - 3. Itemized comparison of original and proposed product addressing product characteristics including but not necessarily limited to:
    - a. Size.
    - b. Composition or materials of construction.
    - c. Weight.
    - d. Electrical or mechanical requirements.

## 4. Product experience:

- a. Location of past projects utilizing product including three of the most recent installations where similar equipment by the manufacturer or manufacturer's representative is currently in service; include contact name, telephone number, mailing address, and the names of the Engineer, Owner, and installation contractor; if three installations do not exist, the list shall include all that do exist, if any.
- b. Available field data and reports associated with proposed product.
- 5. Data relating to changes in construction schedule.
- 6. Data relating to changes in cost.
- 7. Samples:
  - a. As requested by the Engineer/Owner.

## 1.2 APPROVAL OR REJECTION:

- A. Written approval or rejection of substitution given by the Engineer.
- B. Engineer reserves the right to require proposed product to comply with color and pattern of specified product if necessary to secure design intent.
- C. In event substitution results in a change in design or time, provisions in General Conditions will be applied for adjustment.
- D. Substitutions will be rejected if:
  - 1. Submittal is not through the Supplier with their written approval product is of equal quality and service.
  - 2. Requests are not made in accordance with this Section.
  - 3. In the Engineer's opinion, acceptance will require substantial revision of the original design.
  - 4. In the Engineer's opinion, substitution will not perform adequately the function consistent with the design intent, including operational and maintenance impacts.

## SECTION 01640 SUUPLIER'S SERVICES

#### PART 1 - GENERAL

#### 1.1 DEFINITIONS

- A. Reference Section 01650, FACILITY STARTUP
- B. Person-Day: One person for 8 hours within regular CONTRACTOR working hours.

### 1.2 SCOPE

- A. Work under this section defines the minimum scope of services to be provided using factory representatives of the manufacturers of the equipment to be installed during installation, start-up, and operator training.
- B. Equipment manufacturers assigned unit responsibility for systems comprised of several components shall provide the service of factory representative from each component manufacturer to perform the duties required under these Specifications. The equipment manufacturer assigned unit responsibility shall be responsible for coordinating the activities of the system component manufacturers.

### 1.3 SUBMITTALS

- A. Training Schedule: Submit not less than 15 days prior to equipment installation and revise as necessary for acceptance.
- B. Training Materials:
  - 1. Final training materials must be approved by ENGINEER prior to equipment startup and training.
  - 2. Furnish complete outlines of proposed training session, operation and maintenance data for each trainee in attendance.
- C. Quality Control Submittals: As required in the individual Specification, submit:
  - 1. Qualifications of manufacturer's Representative performing specified services.
  - 2. Manufacturer's Certificate of Proper Installation using form provided by SUPPLIER.

## 1.4 QUALIFICATION

A. Qualification of the representatives for installation, startup, and operator training purposes shall be an authorized representative of the manufacturer, factory trained, and experienced in the technical applications, installation, operation and maintenance of the equipment being installed and shall be subject to the approval of the ENGINEER. No substitutions of approved representatives will be allowed without the prior written approval of the ENGINEER.

B. References in various equipment sections of the terms "factory representative" or "field representative" shall mean an employee or contractor of the equipment manufacturer who is trained, articulate, capable of coordinating and expediting training, and familiar with operation and maintenance manual information specified in Section 01782, OPERATION AND MAINTENANCE DATA.

## 1.5 COORDINATION

- A. Contractor shall notify ENGINEER 72 hours prior to any impending visit by factory representatives so that the ENGINEER may be present.
- B. ENGINEER may approve the services of a manufacturer's representative for more than one system during the same site visit.
- C. Installation Contractor shall perform the necessary inspections to ensure that all conditions necessary for successful training and/or startup services have been met prior to scheduling manufacturer's onsite services.

## 1.6 MINIMUM SUPPLIER'S SERVICES REQUIREMENTS

- A. Qualified factory representatives shall furnish manufacturer's services as specified in the Contract Documents.
- B. Where time is specified in the Contract Documents for manufacturer's services, the specified time shall be considered a minimum time and any time in excess of the specified time stated in the specifications to perform the required manufacturer's services shall be considered incidental work. ENGINEER approved days of service will be credited to fulfill the specified minimum manufacturer's services.
- C. Installation Contractor's training and startup schedule shall coordinate manufacturer's services to avoid conflicting with other onsite testing or other manufacturer's services.
- D. Manufacturer's services will include the following, as applicable to the specific system or equipment items:
  - 1. Installation assistance including observation, guidance, instruction of Installation Contractor's assembly, erection, installation or applications.
  - 2. Inspection, checking, and adjustment as required for product (system, subsystem, or component) to function as warranted by manufacturer and necessary to furnish written approval of installation.
  - 3. Additional site visits as necessary to address problems and until installation and operation are acceptable to ENGINEER.
  - 4. Perform, coordinate, and assist during functional and performance testing and startup demonstration, and until product acceptance by the ENGINEER.
  - 5. Training of OWNER'S personnel in the operation and maintenance of respective product as required.

6. Completion of Manufacturer's Certificate of Proper Installation with applicable certificates for proper installation and initial, interim, and final test or service.

#### 1.7 SCHEDULE

- A. Coordinate with Installation Contractor the following.
- B. List specified equipment and systems with respective manufacturers that require training services of manufacturers' representatives and show:
  - 1. Estimated dates for installation completion.
  - 2. Estimated training dates to allow for multiple sessions when several shifts are involved.
- C. Adjust training schedule to ensure training of appropriate personnel as deemed necessary by OWNER, and to allow full participation by manufacturers' representatives. Adjust schedule for interruptions in operability of equipment.

#### 1.8 TRAINING PLAN

- A. Training Plan: Submit for each proposed course:
  - 1. Title and objectives.
  - 2. Schedule of training courses including dates, durations, and locations of each class.
  - 3. Recommended types of attendees (e.g., managers, engineers, operators, maintenance).
  - 4. Course description and outline of course content.
  - Duration.
  - 6. Instruction materials and equipment requirements.
  - 7. Detailed course schedule for each day showing time allocated to each topic.
  - 8. Resumes of instructors providing the training.

#### 1.9 TRAINING OWNER'S PERSONNEL

- A. Manufacturer shall furnish the services of a factory representative to train the operations staff in the operation and maintenance of each item installed under these the Specifications. The time required to perform these services shall be shown in the equipment section, but shall be no less than one (1), eight (8) hour day.
- B. Pre-startup Training:
  - 1. Coordinate training sessions with operating personnel and manufacturers' representatives, and with submission of operation and maintenance manuals in accordance with Section 01782, OPERATION AND MAINTENANCE DATA.
  - 2. Complete at least 14 days prior to actual startup.
- C. Post-Startup Training: If required in Specifications, furnish and coordinate training of OWNER'S operating personnel by respective manufacturer's representatives.

### SECTION 01650 FACILITY STARTUP

### PART 1 - GENERAL

#### 1.1 DEFINITIONS

- A. Reference Section 01640, MANUFACTUER'S SERVICES
- B. Functional Test: A test or tests in the presence of the ENGINEER and OWNER to demonstrate that the installed equipment or system meets manufacturer's installation and adjustment requirements and other requirements specified including, but not limited to, noise, vibration, alignment, speed, proper electrical and mechanical connections, thrust restraint, proper rotation, and initial servicing.
- C. Performance Test: A test performed in the presence of the ENGINEER and OWNER and after any required functional test specified, to demonstrate and confirm that the equipment and/or system meet the specified performance requirements.
- D. System: The overall process, or a portion thereof, that performs a specific function. A system may consist of two or more subsystems as well as two or more types of equipment. Examples of systems on this Project are as follows:
  - 1. Pumps, motors, equipment appurtenances, transducers.
  - 2. Instrumentation and control system(s).

### 1.2 SCOPE

- A. Work under this Section includes, but is not necessarily limited to, the provision of all labor and material required to perform startup of all equipment and mechanical systems installed under this Contract.
- B. Work defined under this Section includes providing the services of a factory representative in accordance with the requirements of Section 01640 MANUFACTURER'S SERVICES.

### 1.3 SUBMITTALS

#### A. Administrative Submittals:

- 1. Functional and performance test schedules and plan for equipment, units, and systems at least 15 days prior to start of related testing. Include test plan, procedures, and log format.
- 2. Schedule and plan of facility startup activities at least 15 days prior to commencement.

### B. Quality Control Submittals:

- 1. Manufacturer's Certificate of Proper Installation as required.
- 2. Test Reports: Functional and performance testing, in format acceptable to ENGINEER and certification of functional and performance test for each piece of equipment or system specified.
- 3. Certifications of Calibration: Testing equipment.

# 1.4 MANUFACTURER AND INSTALLATION CONTRACTOR FACILITY STARTUP RESPONSIBILITIES

#### A. General:

- 1. Perform all Work necessary for functional and performance tests specified in the Contract Documents.
- 2. Demonstrate proper installation, adjustment, function, performance, and operation of equipment, systems, control devices, and required interfaces individually and in conjunction with process instrumentation and control system.
- 3. Complete Work associated with the unit and related processes before testing, including related manufacturer's representative services.
- 4. Installation Contractor shall have, at the plant site, Operation and Maintenance Manuals for equipment to be started.
- 5. Furnish qualified manufacturer's representatives when required to assist in testing.
- 6. Utilize the Manufacturer's Certificate of Proper Installation Form from Section 01640, MANUFACTURERS' SERVICES, supplemented as necessary, to document functional and performance procedures, results, problems, and conclusions.
- 7. Schedule and attend pretest (functional and performance) meetings related to test schedule, plan of test, materials, chemicals, and liquids required, facilities' operations interface, ENGINEER and OWNER involvement.
- 8. Designate and furnish one or more persons to be responsible for coordinating and expediting Installation Contractor's facility startup duties. The person or persons shall be present during facility startup meetings and shall be available at all times during the facility startup period.
- 9. Provide temporary valves, gauges, piping, test equipment and other materials and equipment required to conduct testing.

### 1.5 OWNER/ENGINEER FACILITY STARTUP RESPONSIBILITIES

#### A. General:

- 1. Review CONTRACTOR'S test plan and schedule.
- 2. Witness each functional or performance test.
- 3. Coordinate other plant operations, if necessary, to facilitate testing.
- 4. Provide water, power, chemicals, and other items as required for testing, unless otherwise indicated.

### B. Startup Test Period:

- 1. Operate process units and devices, with support of Installation Contractor.
- 2. Provide sampling, labor, and materials as required and provide laboratory analyses.

#### **PART 3 - EXECUTION**

#### 3.1 TESTING PREPARATION

- A. Cleaning and Checking: Prior to starting functional testing:
  - 1. Calibrate testing equipment for accurate results.
  - 2. Inspect and clean equipment, devices, connected piping, and structures so they are free of foreign material.
  - 3. Lubricate equipment in accordance with manufacturer's instructions.
  - 4. Turn rotating equipment by hand and check motor-driven equipment for correct rotation.
  - 5. Open and close valves by hand and operate other devices to check for binding, interference, or improper functioning.
  - 6. Check power supply to electric-powered equipment for correct voltage.
  - 7. Adjust clearances and torques.
  - 8. Test piping for leaks.
  - 9. Obtain completion of applicable portions of Manufacturer's Certificate of Proper Installation in accordance with Section 01640, MANUFACTURER'S SERVICES.

### B. Startup Test Period:

- 1. As applicable to the equipment furnished, state in writing that all necessary hydraulic structures, piping systems, and valves have been successfully tested; that all necessary equipment systems and subsystems have been checked for proper installation, started, and successfully tested to indicate that they are all operational; that the systems and subsystems are capable of performing their intended functions; and that the facilities are ready for startup and intended operation.
- 2. Attend pre-startup planning meetings and arrange for attendants by key major equipment manufacturer representatives as required by the Contract Documents.
- 3. Designate and provide one or more persons to be responsible for coordinating and expediting Installation Contractor's startup duties.
- 4. When plant startup has commenced, schedule remaining Work so as not to interfere with or delay the completion of plant startup. Support the startup activities with adequate staff to prevent delays, process upsets. This staff shall include, but not be limited to, major equipment and system manufacturers' representatives, subcontractors, electricians, instrumentation personnel, millwrights, pipefitters, plumbers.

- 5. Supply and coordinate specified manufacturer's plant startup services.
- 6. Make adjustments, repairs, and corrections necessary to complete plant startup.
- 7. After the plant is operating, complete the testing of those items of equipment, systems, and subsystems which could not be or were not adequately or successfully tested prior to plant startup.
- C. Ready-to-test determination will be by ENGINEER based at least on the following:
  - 1. Notification by CONTRACTOR of equipment and system readiness for testing.
  - 2. Acceptable testing plan.
  - 3. Acceptable Operation and Maintenance Manuals.
  - 4. Receipt of manufacturer's Certificate of Proper Installation, if specified.
  - 5. Adequate completion of Work adjacent to, or interfacing with, equipment to be tested.
  - 6. Availability and acceptability of manufacturer's representative, when specified, to assist in testing of respective equipment, and satisfactory fulfillment of other specified manufacturers' responsibilities.
  - 7. Equipment and electrical tagging complete.
  - 8. All spare parts and special tools delivered to OWNER.

### 3.2 FUNCTIONAL TESTING—GENERAL

- A. Begin testing at a time mutually agreed upon by the OWNER, ENGINEER, and Installation Contractor.
- B. ENGINEER will be present during test. Notify in writing OWNER, ENGINEER, and manufacturer's representative(s) at least 10 days prior to scheduled date of functional tests.
- C. Separate items of equipment demonstrated to function properly during subsystem testing may require no further functional test if documentation of subsystem testing is acceptable to ENGINEER.
- D. Conduct functional tests as specified for each equipment item or system.
- E. Demonstrate all operational features and instrumentation and control functions while in automatic mode.
- F. If, in ENGINEER'S opinion, functional test results do not meet requirements specified, the systems will be considered as nonconforming.
- G. Performance testing shall not commence until the equipment or system meets the specified functional tests.

### 3.3 PERFORMANCE TEST—GENERAL

A. Begin testing at a time mutually agreed upon by the OWNER, ENGINEER, and Installation Contractor.

- B. ENGINEER will be present during test. Notify in writing OWNER, ENGINEER, and manufacturer's representative(s) at least 15 days prior to scheduled date of functional tests.
- C. Conduct performance tests as specified for each equipment item or system.
- D. Unless otherwise indicated, Installation Contractor shall furnish all labor, materials, and supplies for conducting the test and taking all samples and performance measurements.
- E. Prepare performance test report summarizing test method. Include test logs, pertinent calculations, and manufacturer's written certification that the equipment or system performs as specified.

### 3.4 STARTUP TEST PERIOD

#### A. A. General:

- 1. Attend planning meetings and arrange for attendance by key major equipment manufacturer representatives as required by the Contract Documents.
- 2. When facility startup has commenced, schedule remaining Work so as not to interfere with or delay the completion of facility startup.
- 3. Support facility startup activities with adequate staff to prevent delays. Such staff shall include, but not be limited to, major equipment and system manufacturer's representatives, electricians, instrumentation and control personnel, millwrights, pipefitters, and plumbers.
- 4. Furnish and coordinate specified manufacturer's facility startup services.
- 5. After the facility is operating, complete the testing of those items of equipment, systems, and subsystems which could not or were not successfully tested prior to the startup test period.

### B. Startup Testing:

- 1. Startup of the entire facility or any portion thereof requires the coordinated operation of the facilities by the CONTRACTOR, subcontractors, OWNER'S operating personnel, and manufacturer's representatives.
- 2. Startup test period shall occur after all required functional tests have been completed and those performance tests deemed necessary for the safe operation of the entire facility have been completed.
- 3. Startup of the entire facility or any portion thereof shall be considered complete when, in the opinion of the ENGINEER, the facility or designated portion has operated in the manner intended for 20 continuous days without significant interruption. This period is in addition to any training, functional, or performance test periods specified elsewhere.
- 4. Signification interruption may include any of the following events:
  - a. Failure of CONTRACTOR to maintain qualified onsite startup personnel as schedule.
  - b. Failure to meet specified performance for more than 2 consecutive hours.
  - c. Failure of any critical equipment unit, system, or subsystem that is not

- satisfactorily corrected within 5 hours after failure.
- d. Failure of any non-critical unit, system, or subsystem that is not satisfactorily corrected within 8 hours after failure.
- e. As may be determined by ENGINEER.
- 5. A significant interruption will require the startup then in progress to be stopped and restarted after corrections are made.
- C. Startup Test Reports: As applicable to the equipment furnished, certify in writing that:
  - 1. Hydraulic structures, piping systems, and valves have been successfully tested.
  - 2. Equipment systems and subsystems have been checked for proper installation, started, and successfully tested to indicate that they are operational.
  - 3. Systems and subsystems are capable of performing their intended functions, including fully-automatic.
  - 4. Facilities are ready for intended operation.

### SECTION 01782 OPERATION AND MAINTENANCE DATA

#### PART 1 - GENERAL

### 1.1 SUMMARY

- A. This Section includes administrative and procedural requirements for preparing operation and maintenance manuals, including the following:
  - 1. Operation manuals for systems, subsystems, and equipment.
  - 2. Maintenance manuals for the care and maintenance of products, materials, finishes, systems, and equipment.
- B. See Divisions 16 Sections for specific operation and maintenance manual requirements for the Work in those Sections.

### 1.2 SUBMITTALS

- A. Manual: Submit 3 copies of each manual in final form at least 15 days before final inspection. ENGINEER will return copy with comments within 15 days after final inspection.
  - 1. Correct or modify each manual to comply with ENGINEER's comments. Submit 3 copies of each corrected manual within 20 days of receipt of ENGINEER's comments.

#### **PART 2 - PRODUCTS**

### 2.1 MANUALS, GENERAL

- A. Organization: Unless otherwise indicated, organize each manual into a separate section for each system and subsystem, and a separate section for each piece of equipment not part of a system. Each manual shall contain a title page, table of contents, and manual contents.
- B. Title Page: Enclose title page in transparent plastic sleeve. Include the following information:
  - 1. Subject matter included in manual.
  - 2. Name and address of Project and Project Number.
  - 3. Name and address of OWNER.
  - 4. Date of submittal.
  - 5. Name, address, and telephone number of Manufacturer
  - 6. Name and address of ENGINEER.
  - 7. Cross-reference to related systems in other operation and maintenance manuals.

- C. Table of Contents: List each product included in manual, identified by product name, indexed to the content of the volume, and cross-referenced to Specification Section number in Project Manual.
- D. Manual Contents: Organize into sets of manageable size. Arrange contents alphabetically by system, subsystem, and equipment. If possible, assemble instructions for subsystems, equipment, and components of one system into a single binder.
  - 1. Binders: Heavy-duty, 3-ring, vinyl-covered, loose-leaf binders, in thickness necessary to accommodate contents, sized to hold 8-1/2-by-11-inch (215-by-280- mm) paper; with clear plastic sleeve on spine to hold label describing contents and with pockets inside covers to hold folded oversize sheets.
    - a. Identify each binder on front and spine, with printed title "OPERATION AND MAINTENANCE MANUAL," Project name and number, and subject matter of contents. Indicate volume number for multiple-volume sets
  - 2. Dividers: Heavy-paper dividers with plastic-covered tabs for each section. Mark each tab to indicate contents. Include typed list of products and major components of equipment included in the section on each divider, cross-referenced to Specification Section number and title of Project Manual.
  - 3. Protective Plastic Sleeves: Transparent plastic sleeves designed to enclose diagnostic software diskettes for computerized electronic equipment.
  - 4. Drawings: Attach reinforced, punched binder tabs on drawings and bind with text.
    - a. If oversize drawings are necessary, fold drawings to same size as text pages and use as foldouts.
    - b. If drawings are too large to be used as foldouts, fold and place drawings in labeled envelopes and bind envelopes in rear of manual. At appropriate locations in manual, insert typewritten pages indicating drawing titles, descriptions of contents, and drawing locations.

#### 2.2 EMERGENCY MANUALS

- A. Content: Organize manual into a separate section for type of emergency, emergency instructions, and emergency procedures.
- B. Type of Emergency: Where applicable for each type of emergency indicated below, include instructions and procedures for each system, subsystem, piece of equipment, and component for fire, flood, gas leak, water leak, power failure, water outage, equipment failure, and chemical release or spill.

- C. Emergency Instructions: Describe and explain warnings, trouble indications, error messages, and similar codes and signals. Include responsibilities of OWNER's operating personnel for notification of Installer, supplier, and manufacturer to maintain warranties.
- D. Emergency Procedures: Include instructions on stopping, shutdown instructions for each type of emergency, operating instructions for conditions outside normal operating limits, and required sequences for electric or electronic systems.

#### 2.3 OPERATION MANUALS

- A. Content: In addition to requirements in this Section, include operation data required in individual Specification Sections and equipment descriptions, operating standards, operating procedures, operating logs, wiring and control diagrams, and license requirements.
- B. Descriptions: Include the following:
  - 1. Product name and model number.
  - 2. Manufacturer's name.
  - 3. Equipment identification with serial number of each component.
  - 4. Equipment function.
  - 5. Operating characteristics.
  - 6. Limiting conditions.
  - 7. Performance curves.
  - 8. Engineering data and tests.
  - 9. Complete nomenclature and number of replacement parts.
- C. Operating Procedures: Include start-up, break-in, and control procedures; stopping and normal shutdown instructions; routine, normal, seasonal, and weekend operating instructions; and required sequences for electric or electronic systems.
- D. Systems and Equipment Controls: Describe the sequence of operation, and diagram controls as installed.
- E. Piped Systems: Diagram piping as installed, and identify color-coding where required for identification.

#### 2.4 PRODUCT MAINTENANCE MANUAL

- A. Content: Organize manual into a separate section for each product, material, and finish. Include source information, product information, maintenance procedures, repair materials and sources, and warranties and bonds, as described below.
- B. Source Information: List each product included in manual identified by product name and arranged to match manual's table of contents. For each product, list name, address, and telephone number of Installer or supplier and maintenance service agent, and cross-reference Specification Section number and title in Project Manual.

- C. Product Information: Include the following, as applicable:
  - 1. Product name and model number.
  - 2. Manufacturer's name.
  - 3. Color, pattern, and texture.
  - 4. Material and chemical composition.
  - 5. Reordering information for specially manufactured products.
- D. Maintenance Procedures: Include manufacturer's written recommendations and inspection procedures, types of cleaning agents, methods of cleaning, schedule for cleaning and maintenance, and repair instructions.
- E. Repair Materials and Sources: Include lists of materials and local sources of materials and related services.
- F. Warranties and Bonds: Include copies of warranties and bonds and lists of circumstances and conditions that would affect validity of warranties or bonds.

### 2.5 SYSTEMS AND EQUIPMENT MAINTENANCE MANUAL

- A. Content: For each system, subsystem, and piece of equipment not part of a system, include source information, manufacturers' maintenance documentation, maintenance procedures, maintenance and service schedules, spare parts list and source information, maintenance service contracts, and warranty and bond information, as described below.
- B. Source Information: List each system, subsystem, and piece of equipment included in manual identified by product name and arranged to match manual's table of contents. For each product, list name, address, and telephone number of Installer or supplier and maintenance service agent, and cross-reference Specification Section number and title in Project Manual.
- C. Manufacturers' Maintenance Documentation: Manufacturers' maintenance documentation including maintenance instructions, drawings and diagrams for maintenance, nomenclature of parts and components, and recommended spare parts for each component part or piece of equipment:
- D. Maintenance Procedures: Include test and inspection instructions, troubleshooting guide, disassembly instructions, and adjusting instructions, and demonstration and training videotape if available, that detail essential maintenance procedures:
- E. Maintenance and Service Schedules: Include service and lubrication requirements, list of required lubricants for equipment, and separate schedules for preventive and routine maintenance and service with standard time allotment.
- F. Spare Parts List and Source Information: Include lists of replacement and repair parts, with parts identified and cross-referenced to manufacturers' maintenance documentation and local sources of maintenance materials and related services.

- G. Maintenance Service Contracts: Include copies of maintenance agreements with name and telephone number of service agent.
- H. Warranties and Bonds: Include copies of warranties and bonds and lists of circumstances and conditions that would affect validity of warranties or bonds.

### **PART 3 - EXECUTION**

### 3.1 MANUAL PREPARATION

- A. Product Maintenance Manual: Assemble a complete set of maintenance data indicating care and maintenance of each product, material, and finish incorporated into the Work.
- B. Operation and Maintenance Manuals: Assemble a complete set of operation and maintenance data indicating operation and maintenance of each system, subsystem, and piece of equipment not part of a system.
- C. Manufacturers' Data: Where manuals contain manufacturers' standard printed data, include only sheets pertinent to product or component installed. Mark each sheet to identify each product or component incorporated into the Work. If data include more than one item in a tabular format, identify each item using appropriate references from the Contract Documents. Identify data applicable to the Work and delete references to information not applicable.
- D. Drawings: Prepare drawings supplementing manufacturers' printed data to illustrate the relationship of component parts of equipment and systems and to illustrate control sequence and flow diagrams. Coordinate these drawings with information contained in Record Drawings to ensure correct illustration of completed installation.
  - 1. Do not use original Project Record Documents as part of operation and maintenance manuals.

### SECTION 09900 PAINTING

### PART 1 GENERAL

#### 1.1 SCOPE OF WORK

- A. Furnish all labor, materials, equipment and incidentals required and install all painting complete as shown on the Drawings and as specified herein.
- B. It is the intent of this Section to paint all new, exposed structural and miscellaneous steel and appurtenances, steel doors and frames, steel frames for glazed openings, door closers, pipe, fittings, supports, valves, mechanical and electrical equipment, roof fans, chemical tanks and systems, electrical conduit and appurtenances, sluice gates, operators and posts, interior gypsum work, interior CMU walls (where scheduled), exposed ductwork; all as specified herein, as indicated on the Drawings, and all other work obviously required to be painted unless otherwise specified. Minor items omitted in the schedule of work shall be included in the work of this Section where they come within the general intent of the specifications as stated herein.
- C. Paint items so noted in paragraph 1.1B and in accordance with the Painting Schedule and Color Coding Schedule herein. Provide letters and numbers for markings as specified. Items noted in Painting Schedule and Color Coding Schedule herein as having factory finish and other obviously factory finished items shall not be field painted. The Contractor is responsible for having damaged factory finish painted items repaired or, if so ordered, for replacing items. The various Sections are responsible, as stated in each, for preparation and field touch-up of abrasions, welds, and damaged primed areas of primed or galvanized components after erection.
- D. The following surfaces or items are not required to be painted under this Section:
  - Portions of metal, other than aluminum, embedded in concrete. This does not apply to the back face of items mounted to concrete or masonry surfaces, which shall be painted before erection. Aluminum to be embedded in or in contact with concrete or masonry shall be coated to prevent electrolysis.
  - 2. Non-ferrous metals (except copper) and stainless steels, unless specified or noted otherwise.
  - 3. Fencing.
  - 4. Concealed surfaces of pipe or crawl spaces.
  - 5. Acoustical ceilings and acoustical metal panels.
  - 6. Tile.

- 7. Exterior concrete, unless specified or noted otherwise.
- 8. Door hardware, except door closers that are not finished.
- 9. Manhole frames and covers.
- 10. Fiberglass other than piping.
- 11. Packing glands and other adjustable parts, and nameplates and data plates of mechanical equipment.
- 12. Epoxy flooring.
- 13. Plumbing fixtures.
- 14. Furniture.
- 15. Maintenance equipment.
- 16. Factory prefinished architectural components.
- 17. Membrane roofing.
- 18. Acoustical metal deck.
- 19. Mechanical and electrical equipment that has been factory finished as specified in Divisions 11, 13, 15, and 16.

### 1.2 RELATED WORK

- A. Valve Identification is included in Division 1.
- B. Waterproofing and Dampproofing is included in Division 7.
- C. Surface Preparation and Shop Prime Painting is included in Section 09901.
- D. Building Signage is included in Division 10.
- E. Project signs are included in Division 1.
- F. Concrete is included in Division 3.
- G. Masonry is included in Division 4.
- H. Metals are included in Division 5.

#### 1.3 SUBMITTALS

- A. Submit the following in accordance with Section 01300.
- B. Product Data: For each type of product indicated.
- C. Samples: Submit the following for each type of coating system and in each color and gloss of finish coat indicated.
  - 1. Color cards for initial color selections.
  - 2. Three sets of 8-in by 8-in samples, on 1/4-in hardboard, of all colors required for all types of paint. Resubmit until approved.
- D. Schedule of Painting Operations: Submit to the Engineer, in accordance with Section 01300, a complete Schedule of Painting Operations within 90 days after the Notice to Proceed. This Schedule is imperative so that the various fabricators may be notified of the proper shop prime coat to apply. Properly notify and coordinate the fabricators' surface preparation and painting operations with these specifications. This Schedule shall include for each surface to be painted, the brand name, the percent volume of solids, the coverage, and the number of coats the Contractor proposes to use in order to achieve the specified DFT, and color charts. When the Schedule has been approved, apply all material in strict accordance with the approved Schedule and the manufacturer's instructions. Wet and dry paint film gauges shall be made available to the Engineer to verify the proper application while work is in progress.
- E. Documentation of the compatibility between prime coats and finish coats shall be submitted along with the date and ambient conditions for all prime coat installation with an established recoat window allowed for each prime system. Corrective surface preparation techniques shall be submitted for all systems in the event that the recoat window is missed.
- F. Product List: For each product indicated. Cross-reference products to coating system and locations of application areas. Use same designations indicated on Drawings and in schedules.

#### 1.4 REFERENCE STANDARDS

- A. Steel Structures Painting Council (SSPC)
  - 1. SSPC SP-1 Surface Preparation Specification No. 1 Solvent Cleaning.
  - 2. SSPC SP-2 Surface Preparation Specification No. 2 Hand Tool Cleaning.
- B. Where reference is made to one of the above standards, the revision in effect at the time of bid opening shall apply.

### 1.5 DELIVERY, STORAGE AND HANDLING

- A. All painting materials shall be delivered to the mixing room in unbroken containers, bearing the manufacturer's brand, date of manufacture, and name. They shall be used without adulteration and mixed, thinned, and applied in strict accordance with manufacturer's directions for the applicable materials and surface before using.
- B. Painting materials shall be delivered to the job site in the original unopened containers, bearing the manufacturer's label. A Product Data Sheet and Material Safety Data Sheet for all painting, activators, thinners, accelerators, and other materials shall be obtained from the manufacturer for each shipment of materials to the job site. Painting materials shall be stored in a dry, well- ventilated area, not in direct contact with the ground, where the temperature is maintained between 40 and 120 degrees F. Damaged materials and/or materials exceeding the shelf life shall not be used.
- C. Paints shall be mixed in proper containers of adequate capacity. All paints shall be thoroughly stirred before use and shall be kept stirred while using. No unauthorized thinners or other materials shall be added to any paint. Air shall not be used directly for agitation. Pigmented material shall be strained after mixing. Where application equipment has strainers, they should be sized so as to allow pigment to pass but not foreign material. Multiple (2 or more) component catalyzed materials may not be used beyond the recommended pot life.
- D. Work areas will be designated by the Owner for storage and mixing of all painting materials. Materials shall be in full compliance with the requirements of pertinent codes and fire regulations. Proper containers outside of the buildings shall be provided and used for painting wastes, and no plumbing fixture shall be used for this purpose.
- E. All recommendations of the paint manufacturer in regard to the health and safety of workmen shall be followed.

### 1.6 PROJECT CONDITIONS

- A. Apply coatings only when temperature of surfaces to be coated and surrounding air temperatures are between 50 and 95 deg F.
- B. Do not apply coatings in snow, rain, fog, or mist; when relative humidity exceeds 85 percent; at temperatures less than 5 deg F above the dew point; or to damp or wet surfaces.

#### 1.7 EXTRA MATERIALS

A. Furnish extra materials described below that are from same production run (batch mix) as materials applied and that are packaged for storage and identified with labels describing contents.

1. Quantity: Furnish an additional 5 percent, but not less than 1 gal. of each material and color applied.

### 1.8 QUALITY ASSURANCE

### A. Manufacturer Representative

The Contractor shall require the paint manufacturer to furnish a manufacturer's
qualified technical representative to visit the project site for technical support as
required and ordered and as may be necessary to resolve field questions or
problems attributable to or associated with the manufacturer's products
furnished under this Contract or the application thereof.

### B. Pre-Painting Conference

- 1. Well in advance of commencement of painting operations, but after major equipment has been delivered, a pre-painting conference shall be held. All parties with an interest in the painting work shall attend, including the Contractor, the manufacturer, the Owner, the Engineer, and the painting Contractor. The Contractor shall contact each party and arrange the meeting.
- 2. The conference shall include an inspection of the areas to be painted by all parties and a discussion of the conformance of each area with the specifications. Important issues such as environmental conditions, climate control systems, original primer, DFT, and monitoring the number of coats that have been field applied shall be discussed and problems shall be resolved.
- 3. A written record of the meeting shall be submitted to the Engineer.

#### C. Cold Weather Construction

1. All paint shall be at room temperature before applying, and no painting shall be done when the temperature is below 50 degrees F, in dust-laden air, when rain or snow is falling, or until all traces of moisture have completely disappeared from the surface to be painted. Lower temperatures will only be allowed with written instructions from the paint manufacturer.

### D. Inspection and Testing

- 1. All materials and work shall be accessible and subject to inspection by the Engineer.
- 2. The completed work shall be inspected visually by the Engineer for skips, holidays, hiding, uniform color and appearance, and other imperfections. All defective work shall be corrected by the Contractor.

- 3. Coating thickness on steel shall be determined in accordance with SSPC PA 2. The number of readings will be a minimum of that stated in SSPC PA 2.
- 4. Coating integrity for coatings in immersion areas or subjected to splash and spillage shall be determined in accordance with NACE RP0188-88 using the low voltage wet sponge test method. All holidays will be clearly marked for repair.
- 5. The Contractor shall furnish to the job site and use for coating inspection and make available to the Engineer, the following test equipment:
  - a. Wet film thickness gauge.
  - b. Dry film thickness gauge (with certified thickness calibrator) equal to Mikrotest III; Elcometer Inspector III; or Positest.
  - c. Surface Temperature Gauge.
  - d. Holiday Detector, low voltage type such as Tinker & Rasor Model M-1, Series 9533.
  - e. SSPC VIS-1-89T "Pictorial Surface Preparation Standard."
  - f. Keane-Tator Surface Comparator Number 372, or equal.
  - g. NBS Certified Coating Thickness Standards.
  - h. Sling Psychrometer.
  - i. Surface moisture metering device equal to Delmhors Model DB.

### E. Warranty Inspection

- 1. A warranty inspection shall be conducted during the 11th month following completion of all coating and painting work. The Contractor, painting Contractor, and a representative of the coating material manufacturer shall attend this inspection with the Engineer and representative of the Owner.
- 2. All defective work shall be repaired in accordance with these specifications and to the satisfaction of the Engineer. The Owner may, by written notice to the Contractor, reschedule the warranty inspection to another date within the 1-year correction period or may cancel the warranty inspection altogether. If a warranty inspection is not held, the Contractor is not relieved of his responsibilities under the Contract Documents.

### **PART 2 PRODUCTS**

### 2.1 MATERIALS

A. All painting materials shall be supplied by one manufacturer, unless otherwise approved by the Engineer. The paint schedule has been prepared on the basis of Tnemec Company Inc. products and application recommendations, unless otherwise noted in the schedule. Equals by Ameron (VyGuard), Carboline, or ICI/Devoe. All materials shall meet NSF Standard 61 and be fully equal to the Tnemec products listed in the following schedule. No brand other than those named will be considered for approval unless the brand and type of paint proposed for each item in the following schedule together with sufficient data substantiated by certified tests, conducted at no

expense to the Owner, to demonstrate its equality to the paint(s) named, is submitted in writing to the Engineer for approval within 30 days after the signing of the Notice to Proceed. The type and number of tests performed shall be subject to the Engineer's approval.

- B. Shop priming shall be done with primers that are guaranteed by the manufacturer to be compatible with the finish paints to be used. Refer to Section 09901 for special primers.
- C. No paint containing lead will be allowed. Oil shall be pure boiled linseed oil.

L. Any surfaces not specifically named in the Schedule and not specifically excepted shall be prepared, primed, and painted in the manner and with materials consistent with these specifications. The Engineer shall select which of the manufacturer's products, whether the type is indicated herein or not, shall be used for such unnamed surfaces. No extra payment shall be made for this painting.

#### 2.4 LETTERING OF TITLES

- A. Each pipe system shall be labeled with the name of the materials in each pipeline and alongside this an arrow indicating the direction of flow of liquids. Titles shall be as so described in attached schedule. Titles shall not be located more than 5-li-ft apart, and shall also appear directly adjacent to each side of any wall the pipeline breaches, adjacent to each side of the valve regulator, flowcheck, strainer cleanout, and all pieces of equipment.
- B. Titles shall identify the contents by complete name. Identification title locations shall be determined by the Engineer but in general they shall be placed where the view is unobstructed and on the two lower quarters of pipe or covering where they are overhead. Title should be clearly visible from operating positions especially those

- adjacent to control valves.
- C. Titles on equipment shall be applied at eye level on machines where possible or at the upper most broad vertical surface of low equipment. Where more than one piece of the equipment item to be titled exists, the items shall be numbered consecutively as indicated on the mechanical drawings or as directed by the Engineer; for example Pump No. 1, Pump No. 2, etc. Titles shall be composed and justified on the left hand side as follows:
  - 1. Pump No. 1

### D. Application of titles

- 1. The color of the titles shall be black or white, as approved, to best contrast with the color of the pipes and equipment and shall be stencil applied.
- 2. Text is to be in ALL CAPS worded exactly as shown in the Schedule. Titles are to be printed in a single line.
- 3. Letter sizes

Equipment titles are to be 2-in high.

- 4. Arrow sizes. Where "a" is equal to 3/4 of outside diameter of pipe or covering, the arrow shaft shall be 2 "a" long by 3/8 "a" wide. The arrow head shall be an equilateral triangle with sides equal to "a." Maximum "a" dimension shall be 6-in.
- 5. When using direction arrows, point arrowhead away from pipe markers and in direction of flow. If flow can be in both directions, use a double-headed directional flow.

### 2.5 TITLES FOR EQUIPMENT

A. Titles shall be provided in vinyl film on all equipment using 2-in high Optima Bold upper case, Grid 2 spacing, white or black in color as approved depending on substrate. Titles shall be mounted at eye level on machines where possible or at the

upper most broad vertical surface of low equipment. Where more than one piece of the equipment item to be titled exists, the items shall be numbered consecutively as indicated on the mechanical drawings or as directed by the Engineer; for example Pump No. 1, Pump No. 2, etc. Titles shall be composed in more than one line if required and justified on the left-hand side as approved.

### 2.6 METAL TAGS

A. For pipelines smaller than 3/4-in in diameter, securely fasten metal tags, 2-1/2-in by 1/2-in, of Birmingham or Stubs aluminum with lettering etched and filled with enamel. Tags shall be approved by the Engineer.

### 2.7 VALVE MARKERS

A. Furnish and install aluminum tags with engraved lettering as approved by Engineer on all above ground chemical system and process piping valves.

#### 2.8 FABRICATED EQUIPMENT

- A. Unless otherwise indicated, all fabricated equipment shall be shop primed and shop or field finished.
- B. All items to be shop primed shall be thoroughly cleaned of all loose material prior to priming. If, in the opinion of the Engineer, any prime coating shall have been improperly applied or if material contrary to these specifications shall have been used, that coating shall be removed by sandblasting to white metal and reprimed in accordance with these specifications.
- C. All shop prime coats shall be of the correct materials and applied in accordance with these specifications. Remove any prime coats not in accordance with these specifications by sandblasting and apply the specified prime coat at no additional cost to the Owner.
- D. Shop primed surfaces shall be cleaned thoroughly and damaged or bare spots retouched with the specified primer before the application of successive paint coats in the field.
- E. The Contractor shall be responsible for and take whatever steps are necessary to properly protect the shop prime and finish coats against damage from weather or any other cause.
- F. A shop finish coat shall be equal in appearance and protection quality to a field applied finish coat. If, in the opinion of the Engineer, a shop finish coat does not give the appearance and protection quality of other work of similar nature, prepare the surfaces and apply the coat or coats of paint as directed by the Engineer to accomplish the desired appearance and protection quality. Submit to the Engineer substantial evidence that the standard finish is compatible with the specified finish coat.

#### PART 3 EXECUTION

#### 3.1 EXAMINATION

- A. Examine substrates and conditions, with Applicator present, for compliance with requirements for maximum moisture content and other conditions affecting performance of work.
  - 1. Maximum Moisture Content of Substrates: When measured with an electronic moisture meter as follows:
    - a. Concrete: 12 percent.
    - b. Masonry (Clay and CMU): 12 percent.
    - c. Wood: 15 percent.
    - d. Gypsum Board: 12 percent.
  - 2. Verify compatibility with and suitability of substrates, including compatibility with existing finishes or primers.
  - 3. Begin coating application only after unsatisfactory conditions have been corrected and surfaces are dry.
  - 4. Coating application indicates acceptance of surfaces and conditions.

### 3.2 PREPARATION

- A. All surfaces to be painted shall be prepared as specified herein and shall be dry and clean before painting. Special care shall be given to thoroughly clean interior concrete and CMU surfaces to receive polyamide cured epoxy paint of all marks before application of finish.
- B. All metal welds, blisters, etc, shall be ground and sanded smooth. All pits and dents shall be filled and all imperfections shall be corrected so as to provide a smooth surface for painting. All rust, loose scale, oil, tar and asphalt bearing coatings, grease and dirt shall be removed by use of approved solvents, wire brushing, grinding or sanding.
- C. Concrete surfaces shall have been finished as specified in Section 03350. Report unsatisfactory surfaces to the Engineer. Concrete shall be left for one month minimum before painting and shall be free of dust, oil, curing compounds and other foreign matter.
- D. Concrete masonry unit surfaces shall be smooth and cleaned of all dust, loose mortar and other foreign matter.
- E. All PVC pipe and other plastic matrix surfaces to be painted shall be sanded to an approved profile and cleaned of residue before painting.

- F. All PVC pipe and other plastic matrix surfaces to be painted shall be lightly sanded and cleaned of residue before painting.
- G. Galvanized, aluminum, and copper surfaces shall have all oxidation and foreign material removed before painting by SSPC SP-1, using an approved V.O.C. compliant method. Galvanized and, when ordered, the other metal surfaces specified above shall be hand tool cleaned to SSPC SP-2 standards to provide a uniform 1 mil surface profile.

### H. Existing Surfaces to be Repainted

- 1. Existing masonry, steel and other previously field painted surfaces indicated on drawings, or so noted, shall be repainted.
- 2. Preparation shall be in general as specified above for new surfaces except that all loose paint shall be removed and all edges of existing paint shall be feathered to ensure a smooth surface.
- 3. Paint removal, capture of its residue, and its disposal shall be handled in accordance with all laws and regulations concerning disposal of hazardous materials.
- 4. Primer (spot) and paint used for a particular surface shall, in general, be as scheduled for that type of new surface. Provide an approved organic zinc-rich (min. 83% zinc in dried film) primer as specified. Confirm with the paint manufacturer that the paint proposed for a particular repaint condition will be compatible with the existing painted surface. Perform adhesion and compatibility tests on existing substrates as ordered and required. Repainted areas shall be covered by the same guaranty specified for remainder of Project.

#### 3.3 WORKMANSHIP

#### A. General

- At the request of the Engineer, sample areas of the finished work prepared in strict accordance with this Section shall be furnished and all painting shall be equal in quality to the approved sample areas. Finished areas shall be adequate for the purpose of determining the quality of workmanship. Experimentation with factory or paint manufacturer's warehouse mixed colors shall be furnished to the satisfaction of the Engineer where standard chart colors are not satisfactory.
- 2. Protection of furniture and other movable objects, equipment, fittings and accessories shall be provided throughout the painting operation. Canopies of lighting fixtures shall be loosened and removed from contact with surface, covered and protected and reset upon completion. Remove all electric plates,

surface hardware, etc, before painting, protect and replace when completed. Mask all machinery name plates and all machined parts not receiving a paint finish. Dripped or spattered paint shall be promptly removed. Lay drop cloths in all areas where painting is being done to adequately protect flooring and other work from all damage during the operation and until the finished job is accepted.

3. On metal surfaces apply each coat of paint at the rate specified by the manufacturer to achieve the minimum dry mil thickness required. If material has thickened or must be diluted for application by spray gun, the coating shall be built up to the same film thickness achieved with undiluted material. One gallon of paint as originally furnished by the manufacturer shall not cover a greater area when applied by spray gun than when applied unthinned by brush. Deficiencies in film thickness shall be corrected by the application of an additional coat(s). On masonry, application rates will vary according to surface texture; however, in no case shall the manufacturer's stated coverage rate be exceeded. On porous surfaces, it shall be the painter's responsibility to achieve a protective and decorative finish either by decreasing the coverage rate or by applying additional coats of paint.

### B. Field Priming

- 1. Steel members, metal castings, mechanical and electrical equipment and other metals which are shop primed before delivery at the site will not require a prime coat on the job. All piping and other bare metals to be painted shall receive one coat of primer before exposure to the weather, and this prime coat shall be the first coat as specified in the painting schedule. Surface preparation of bare metal shall be the responsibility of the Contractor.
- 2. Equipment which is specified to receive a baked-on enamel finish or other factory finish shall not be field painted unless the finish has been damaged in transit or during installation. Surfaces that have been shop painted and have been damaged, or where the shop coat or coats of paint have deteriorated, shall be properly cleaned and retouched before any successive painting is done on them in the field. All such field painting shall match as nearly as possible the original finish. Preparation and painting shall be provided by the Contractor.
- 3. Equipment shipped with a protective shop painting coat or coats shall be touched up to the satisfaction of the Engineer with primers as recommended by the manufacturer of the finish paint. Preparation and painting shall be provided by the Contractor.

### C. Field Painting

- 1. All painting at the site shall be under the strict inspection of the Engineer. Only skilled painters and, where dictated by special conditions or systems and so ordered, specialist painters shall be used on the work.
- 2. All paint shall be at room temperature before applying, and no painting shall be done when the temperature is below 60 degrees F, in dust-laden air, when rain or snow is falling, or until all traces of moisture have completely disappeared from the surface to be painted.
- 3. Successive coats of paint shall be different shades (from paint manufacturer's stock or shop mixed paint) of the required colors so as to make each coat easily distinguishable from each other with the final undercoat the approximate shade of the finished coat to ensure no show-through as approved.
- 4. Finish surfaces shall not show brush marks or other irregularities. Undercoats shall be thoroughly and uniformly sanded with the type paper appropriate for the undercoats to remove defects and provide a smooth even surface. Top and bottom edges of doors shall be painted.
- 5. Painting shall be continuous and shall be accomplished in an orderly manner so as to facilitate inspection. Materials subject to weather shall be primed coated as quickly as possible. Surfaces of exposed members that will be inaccessible after erection shall be cleaned and painted before erection.
- 6. All painting shall be performed by approved methods with number of coats modified as required to obtain the total dry film thickness specified. Spray painting shall be performed specifically by methods submitted and as approved by the Engineer.
- 7. All surfaces to be painted as well as the atmosphere in which painting is to be done shall be kept warm and dry by heating and ventilation, if necessary, until each coat of paint has hardened. Any defective paint shall be scraped off and repainted in accordance with the Engineer's directions.
- 8. Before final acceptance of the work, all damaged surfaces of paint shall be cleaned and repainted as directed by the Engineer.
- 9. Only the aluminum work noted on the Drawings or in the Painting Schedule shall be field painted.

### 3.4 FIELD QUALITY CONTROL

A. Owner reserves the right to invoke the following procedure at any time and as often as Owner deems necessary during the period when coatings are being applied:

- 1. Owner will engage the services of a qualified testing agency to sample coating material being used. Samples of material delivered to Project site will be taken, identified, sealed, and certified in presence of Contractor.
- 2. Testing agency will perform tests for compliance with specified requirements.
- 3. Owner may direct Contractor to stop applying coatings if test results show materials being used do not comply with specified requirements. Contractor shall remove noncomplying coating materials from Project site, pay for testing, and recoat surfaces coated with rejected materials. Contractor will be required to remove rejected materials from previously coated surfaces if, on recoating with complying materials, the two coatings are incompatible.

#### 3.5 CLEANING AND PROTECTION

- A. At end of each workday, remove rubbish, empty cans, rags, and other discarded materials from Project site.
- B. After completing coating application, clean spattered surfaces. Remove spattered coatings by washing, scraping, or other methods. Do not scratch or damage adjacent finished surfaces.
- C. Protect work of other trades against damage from coating operation. Correct damage by cleaning, repairing, replacing, and recoating, as approved by Engineer, and leave in an undamaged condition.
- D. At completion of construction activities of other trades, touch up and restore damaged or defaced coated surfaces.

### 3.6 COLOR CODING FOR PIPES AND EQUIPMENT

- A. Color coding shall consist of color code painting and identification of all exposed conduits, trough items, and pipelines for the transport of gases, liquid, and semiliquids including all accessories such as valves, insulated pipe coverings, fittings, junction boxes, bus bars, connectors, and all operating accessories which are integral to the whole functional mechanical pipe and electrical conduit system. Colors shall be as noted in the Color Coding Schedules at the end of this Section.
- B. All hangers and pipe support floor stands shall be painted the same color and with the same paint as the pipe it supports. The system shall be painted up to but not including the flanges attached to the mechanical equipment nor the flexible conduit connected to electrical motors. When more than one pipe system is supported on the same bracket, the bracket shall be painted the same color as the adjacent wall or ceiling. Colors shall be as noted in the Color Coding Schedule as selected and approved by Engineer.
- C. All systems that are an integral part of the equipment, that is originating from the

- equipment and returning to the same piece of equipment, shall be painted between and up to but not including, the fixed flanges or connections on the equipment.
- D. The color code establishes, defines, and assigns a definite color for each category of pipe. Pipelines, equipment, or other items that are not listed in the Color Coding Schedule shall be assigned a color by the Engineer and shall be treated as an integral part of the Contract.
- E. Banding for pipes shall be as specified in the Color Coding Schedule. Bands shall be 2-in wide and spaced 5-ft on center, located on each end of the pipe title, at 2-ft from the title bands, and at wall penetrations.
- F. All moving parts, drive assemblies, and covers for moving parts which are potential hazards shall be Safety Orange #CA26.
- G. All safety equipment shall be painted in accordance with OSHA standards.
- H. All inline equipment and appurtenances not assigned another color shall be painted the same base color as the piping. The pipe system shall be painted with the pipe color up to but not including the flanges attached to pumps and mechanical equipment assigned another color. Tanks shall be painted the color of the piping system that they serve, unless the tank is fiberglass and levels are monitored through the tank.
- I. All conduit shall be painted to match its background surface.
- J. Control panels shall be factory finished.
- K. All colors will be confirmed by the Engineer from color charts submitted by the Contractor, based on the color coding schedule herein.

#### 3.7 COLOR IDENTIFICATION

- A. All color numbers and names herein refer to master color card. Colors of specified equal manufacturers may be substituted with approval of the Engineer.
- B. Building surface colors shall be painted as scheduled in the Color Coding Schedule or as selected by the Engineer.
- C. The following Tnemec colors shall be used as a basis for the Color Coding Schedule:

# SECTION 11215 VERTICAL TURBINE EFFLUENT PUMPS

## PART 1 - GENERAL

## 1.01 WORK INCLUDED

- A. This Section covers the work necessary for furnishing vertical turbine pumps, complete with accessories, for reuse pumping.
- B. Installation shall be performed by the Installing Contractor in accordance with Drawings and Specifications to provide a working system.

## C. Related work:

- 1. Documents affecting Work of this Section include, but are not necessarily limited to, General Conditions, Supplementary Conditions, and Sections in Division 1 of these Specifications.
- 2. Painting as included in Section 09900
- 3. Electrical as included in Division 16

### 1.02 SPARE PARTS

- A. Provide standard spare parts as recommended by the equipment manufacturer for one (1) year of service at design loading, as well as the following part(s):
  - 1. One set of all pump shaft and driver bearings.
- B. Furnish all special tools and test equipment required for the proper servicing of all equipment. All such tools and test equipment shall be furnished in a suitable steel tool chest.
- C. All spare parts shall be properly protected for long periods of storage and packed in containers that are clearly identified markings as to contents.

## 1.03 QUALITY ASSURANCE

- A. Referenced manufacturers are National Pump Company, Fairbanks Nijhuis, Layne/Verti-Line, Patterson Pump Company, Xylem Goulds or Peerless Pump Company. Equal products of other manufacturers complying with these specifications may be provided as outlined in the Bid Form and as approved by the Engineer. The SUPPLIER shall submit completed pump data sheets similar to that included at the end of this section.
- B. Technical Services: Provide service of manufacturer's service engineer, complying

# with the following:

- Erection and installation: Two days, one trip.
- Start-up and training: Two days, one trip
- b. To assure unity of responsibility, the motors, and supporting sole plates shall be furnished and coordinated by the pump manufacturer. The manufacturer shall assume responsibility for the satisfactory operation of the entire pumping system including pumps, motors, and sole plates, as specified.
- c. The equipment furnished shall be designed and constructed to operate satisfactorily when installed as shown on the Drawings.

#### 1.04 REFERENCE STANDARDS

- A. Design, manufacturing and assembly of elements of the equipment specified herein shall be in accordance with, the following:
  - 1. American Gear Manufacturers Association (AGMA)
  - 2. American Institute of Steel Construction (AISC)
  - 3. American Iron and Steel Institute (AISI)
  - 4. American Society of Mechanical Engineers(ASME)
  - 5. American National Standards Institute (ANSI)
  - 6. American Water Work Association (AWWA)
  - 7. American Welding Society (AWS)
  - 8. American Bearing Manufacturers Association (ABMA)
  - 9. Hydraulic Institute Standards 2.6
  - 10. Institute of Electrical and Electronics Engineers (IEEE)
  - 11. National Electrical Code (NEC)
  - 12. National Electrical Manufacturers Association (NEMA)
  - 13. Occupational Safety and Health Administration (OSHA)
- B. Where reference is made to one of the above standards, the revision in effect at the time of bid opening shall apply.

## 1.05 DELIVERY STORAGE AND HANDLING

- A. All parts shall be properly protected so that no damage or deterioration will occur during a prolonged delay from the time of shipment until installation is completed and the unit and equipment are ready for operation.
- d. All equipment and parts must be properly protected against any damage during shipment. Store the equipment in accordance with manufacturer's recommendations.

- e. Factory assembled parts and components shall not be dismantled for shipment unless transportation restrictions require a partial dis-assembling of the unit, and the CMAR is notified and acknowledges in writing.
- f. The finished surfaces of all exposed flanges shall be protected by wooden or equivalent blank flanges, strongly built and securely bolted thereto.
- g. Finished iron or steel surfaces not painted shall be properly protected to prevent rust and corrosion.
- h. For protection of bearings during shipment and installation, the bearing shall be properly processed. Anti-friction bearings, if pre-lubricated, shall be protected in accordance with the bearing manufacturer's recommendations against formation of rust during a long period of storage while awaiting completion of installation and start-up of the machine in which they are used. Anti-friction bearings which are not pre-lubricated shall be properly treated in accordance with the bearing manufacturer's recommendation against formation of rust during a long period of storage while waiting completion of installation and start-up by the application of Exxon, Rust-Ban No. 392 or equal treatment.

    - f. Minimum shutoff head: 210 feet
    - g. Column size: 14"
    - h. Discharge flange: 14"
    - i. Operational current: 460 v, 3 phase, 60 hertz
  - 2. FWB Reuse Pump Nos. 1 and 2
    - a. Primary design point: 1,400 gpm at 75' TDH
    - b. Efficiency at primary design point: 79-percent
    - c. NPSHR: 8.8'
    - d. Maximum speed: 1,200 rpm

- e. Motor Horsepower: 50 hp
- f. Minimum shutoff head: 123 feet
- g. Column size: 10"
- h. Discharge flange: 10"
- i. Operational current: 460 v, 3 phase, 60 hertz
- 3. Provide pumps with net positive suction head requirements (NPSHR) less than the net positive suction head available (NPSHA) at all operating conditions.

# C. Impellers:

- 1. Furnish enclosed type, carefully machined and dynamically balanced.
  - a. Provide of silicon bronze ASTM B 584 C87500.
  - b. Lock securely to the Type 416 stainless steel bowl shaft using a Type 416 stainless steel collet, for bowls 18" and larger, and Type 316 stainless steel collet for bowls 16" and smaller.

## D. Bowls:

- 1. Furnish cast iron Class 30 bowls with properly designed guide vanes.
- 2. Fusion bonded epoxy lined bowls.
  - a. Provide coatings in contact with water that are NSF certified.
- 3. Use leaded bronze SAE660 bowl bearings.
- 4. Fit each bowl casing with replaceable bronze or cast iron wear rings, compatible with the bowl assembly material.

# E. Discharge column and lineshaft:

- 1. Furnish outer discharge column of carbon steel ASTM A 53 Grade A36 with flanged joints and Type 316 stainless steel bolting.
- 2. Provide column and lineshaft in maximum lengths of five feet.
- 3. Furnish Type 416 stainless steel lineshaft, with Type 316 stainless steel sleeves at each bearing point and Type 416 stainless steel screw couplings.
- 4. Place lineshaft sleeves on full size shaft (no undercutting) and secure in place without welding.
  - a. Replacement sleeves shall permit field installation without special tools.
- 5. Provide lineshaft of adequate size to transmit the full horsepower of the pumping unit without slip, vibration or excessive elongation.

- a. Provide keyed design of lineshaft capable of taking rotation in either direction.
- b. Provide stainless steel ASTM A276 Type 304 lineshaft couplings including keys and fasteners.
- c. Threads, except on fasteners, will not be accepted in the construction of the couplings.

# F. Lineshaft bearings:

- 1. For column 12" and smaller use Bronze ASTM A 534-C93200 bearings with cast iron retainers, column flanges to be maintained with register fits at the column flanges and bearing retainer.
- 2. For column 14" and larger use rubber bearings with integral steel retainers, the retainers to be bored on a completed column assembly, and the flanges machined for a register fit.

# G. Discharge head:

- 1. Provide discharge head of ASTM A48 cast iron construction or fabricated from ASTM A-36 steel with a minimum 3/8" wall thickness.
- 2. Provide with miterless long radius elbow.
- 3. Furnish with suitable centering ring to receive a vertical hollow shaft motor.
- 4. Design heads for above ground discharge and fit with flanged discharge of size indicated in pump schedule.
  - a. Use ANSI 125 lb. flange on cast heads.
  - b. Use 150 lb. design flange on fabricated heads.
- 5. Provide stuffing box fitted with split type follower and a Type 316 stainless steel sleeve, o-ring mounted and easily replaced through the stuffing box.
- 6. Provide pre-lube (water) connection.
- 7. Furnish two-piece, Type 416 stainless steel headshaft with Type 416 stainless steel flanged coupling with Type 316 stainless steel bolts.

# H. Base plates:

- 1. Provide with separate cast iron sub-base to be permanently grouted and anchored to concrete foundation.
- 2. Plates to be drilled and tapped to accept pump base flange and anchor bolts.

3. Use stainless steel anchor bolts for anchoring base plate to the concrete base.

# I. Factory coatings:

- 1. Prime coat interior and exterior of pump and exterior of motor per Section 09900 in the manufacturer's shop before shipment.
- 2. Finish coat interior and exterior of pump column and bowl assembly and interior of discharge discharge per Section 09900.
- 3. Manufacturer's standard color may be applied to surfaces that will be hidden from view in the final installation.
- J. Nameplate: Provide each pumping unit with a stainless steel nameplate with the following information:
  - 1. Manufacturers name, address and telephone number.
  - 2. Model number.
  - 3. Serial number.
  - 4. Head, capacity and RPM at rated condition.
  - 5. Motor horsepower, RPM and frame size.

## K. Mechanical seals:

- 1. Provide mechanical seals unless specified otherwise.
- 2. Provide stationary balanced O-ring type.
- 3. Materials:
  - a. Metal parts except springs: 316 stainless steel.
  - b. Springs: Hastelloy C.
  - c. Seal faces: Unfilled carbon graphite silica-free grade 99.55 ceramic.
  - d. Elastomers: Viton.
- 4. Acceptable Manufacturer: Chesterton or equal.

### 2.02 DRIVE MOTOR

### A. General:

- 1. Provide direct connected, high efficiency, totally enclosed, fan cooled, corrosive and mill duty, vertical hollow shaft, squirrel cage induction motors, built to form an integral part of the pump head assembly.
  - a. Elgin Reuse Pump Nos. 1 and 2: Inverter duty motor rated for future VFD service.
  - b. FWB Reuse Pump Nos. 1 and 2: Inverter duty motor rated for future VFD service.
- 2. Provide energy efficient motors which have nominal efficiencies equal to or greater than that stated in NEMA MG-1.
- 3. Motors shall utilize the inverter grade insulation system which consists of at a minimum Class F or better insulation materials with additional phase insulating material, extra end-turn bracing and Class H spike resistant wire. The resultant system shall withstand 2000 volt transients without premature motor failure and have no cable limitations in motor application.
- 4. Motors shall operate successfully under inverter running conditions at rated load with variation in the voltage or the frequency not exceeding the following conditions:
  - a. +/-10% rated voltage at rated constant volts/hertz ratio except for specific torque boost situations.
  - b. Motors shall operate successfully under running conditions at rated load and volts/hertz ratio when the voltage unbalance at the motor terminals does not exceed one percent.
- 5. Inverter Operating Characteristics With rated volts/hertz ratio applied, motor performance shall be as follows for critical operating characteristics:
  - a. Torque Motors shall meet or exceed the minimum locked rotor (starting) and breakdown torque specified in NEMA Standard MG1 Part 12 for Design B for the rating specified when on sine wave power.
  - b. Currents -Maximum overload current shall be 150% of nameplate for 60 seconds or 175% for 3 seconds.
- 6. Motors shall not be overloaded at the design condition or at any point on the pump curve, excluding the service factor.
- 7. Provide minimum service factor of 1.15 and bearings designed for an average life of 20 years.
- 8. Provide non-reversing ratchets.

- 9. Furnish high thrust or extra high thrust in conformance with thrust requirements of the pump schedule.
- 10. Furnish motor in current NEMA design, cast iron frame with copper windings, and having a minimum efficiency rating of 90% and a minimum power factor rating of 85%.
- 11. Maximum sound pressure level of the motors, when measured at a distance of one meter away shall not exceed 90 dB(A).
- 12. Thermal protection system consisting of thermistors and a monitoring relay:
  - a. Three (3) thermistors embedded in the coils, one in each phase, protecting the stator windings from damaging temperatures resulting from motor overload, too-frequent starting, blocked air passages, and locked-rotor current.
  - b. Monitor and alarm panel enclosure shall be NEMA 4X stainless steel with hinged cover.
  - c. Provide power from panel from the motor controller.
  - d. Panel shall contain adjustable RTD monitors and relays that will latch when a high temperature setting is reached.
  - e. Panel door shall include two LED type indicating lights, one for winding high temperature and one for bearing high temperature, and one alarm reset pushbutton.
- 13. Provide silicone rubber strip type space heaters rated 120 volts.
- 14. Acceptable manufacturers: Baldor, U.S. Motors, General Electric, or equal.
- B. Characteristics: Provide motors properly selected to perform under these operating conditions:

### 2.03 PRESSURE GAUGES

- A. Provide pressure gauges where indicated on the drawings and not otherwise specified in separate sections of these Specifications.
  - 1. Provide solid front rounded type, 4 or 4-1/2" phenolic or stainless steel case with blow-out back, Type 316 stainless steel bourdon tube, glycerin fill, 1/2" NPT bottom male threaded connection, Teflon coated 400 series, stainless steel rotary movement, black micro-adjusted corners and black figures with white plastic dials, and a threaded ring.
  - 2. Provide gauge accurate to within 1/2% of the total scale range.
  - 3. Provide glycerin filled diaphragm isolators on all gauges except for those

used on potable water systems.

- a. Provide diaphragm material resistant to chemicals in the process line being measured.
- b. Type 316L stainless steel housing and components.
- c. 1/2" connection.
- d. Provide fill/bleed connection.
- e. Viton o-rings with Teflon back-up ring.
- 4. Select gauge at the nearest standard range which provides a top limit above the pump shutoff head at the operating conditions but no greater than 10% above the shut off head.
- 5. Each gauge connection to consist of a shutoff valve and 1/2" stainless steel piping connections.
  - a. Shutoff valve to be Type 316 stainless steel ball valve with T-handle operator.
- 6. Provide gauges manufactured by Ametek, Ashcroft, U.S. Gauge or Wika.

# 2.04 SPECIAL COATINGS

A. Manufacturer shall coat inside and outside of column piping, outside of bowls and inside of discharge head. Themec system of 3 mils Series Omnithane, 4 mils of Series N149-1255 Pota-Pox and 4 mils Series N140-15BL White Pota-Pox.

## 2.05 AIR RELEASE VALVE

A. Provide automatic air release valves to suite the pumping conditions.

# 2.06 INSTRUMENTS

- A. The following instruments shall be supplied for the project:
  - 1. Float switches. The total number of floats supplied shall be as dictated by the project plans. The floats shall match the Owner's standard.
  - 2. Submersible pressure transducer (level). The submersible pressure transducer shall match the Owner's standard. The transducer shall be provided with cable clamp installation/mounting hardware.
  - 3. Pressure transducer (system pressure): The pressure transducer shall match the Owner's standard throughout the distribution system.

#### **PART 3 - EXECUTION**

## 3.01 INSTALLATION

- A. Install the pump in accordance with the pump Manufacturer's directions and these Specifications.
- B. Handle carefully and protect the pump and appurtenances to avoid damaging the equipment. If the pump and column are laid down, support them with blocks to prevent damage. Install pumps with shaft plumb. Level base by means of steel wedges (steel plates and steel shims). Wedge taper shall not be greater than 1/4-inch per foot. Use double wedges to provide a level bearing surface for the pump base. Secure each pair of wedges in their final positions with tack weld on each side after leveling is complete. Accomplish wedging so that there is not change of level or springing on the foundation when the foundation bolts are tightened. Adjust pump assemblies such that the driving units are properly aligned, plumb, and level with the driven units and all interconnecting shafts and couplings. Flexible couplings shall not be considered to compensate for misalignment. Carefully fit and coat all bolt threads with lubricant to facilitate future removal.
- C. After the pump has been set in position, aligned, and wedged to the proper elevation, grout the space between the bottom of the pump baseplate and the concrete foundation. Use a poured, non-shrinking grout. The arrangement of the column shall be straight and vertical when the installation is complete. Grout shall be water tight to prevent static water from escaping.

### 3.02 PAINTING

A. Shop and field painting for the aboveground discharge head, motor, piping and associated exposed metals shall be in accordance with and as specified in Section 09900 Painting.

### 3.03 TESTING

- A. Prior to acceptance of the installed pump, demonstrate proper operation of the pump at the guarantee point, at which time data shall be taken on the total head, flow, and horsepower requirements of the pump. Furnish all instruments and labor required for this procedure.
- B. A test log shall be presented to the ENGINEER upon the completion of **the field test that records the following:**
- 1. Flow, measured by flowmeter.
- 2. Discharge pressures as measured by calibrated gauges, converted to feet of liquid pumped and corrected to centerline discharge, calculated velocity heads at discharge flanges and total head, all tabulated in feet.
- 3. Motor phase-to-phase voltage, phase current and 3-phase kilowatts.

- C. Balance of Vibration: The rotating parts of each pump and its driving motor shall be statically and dynamically balanced before final assembly. The driving motor alone shall operate without vibration in excess of the limited stated in the latest revision of NEMA MG 1. The complete unit, consisting of the motor and pump, connected and in normal operation, shall not develop amplitudes of vibration exceeding limits recommended by the latest revision of Hydraulics Institute Standards for vertical turbine pumps handling clean liquids.
- D. Test Failures: Units failing the field tests shall be realigned and retested.
