After reviewing your proposal in accordance with the terms, conditions, requirements, and criteria stated in the announcement, we regret to inform you that your proposal, "Choctawhatchee Bay Estuary Program Development," was not selected for award based on the scoring of the proposal in accordance with the stated ranking and selection factors in the RESTORE Estuary Program (Planning) Request for Proposals. The competition was very strong, the quality of the proposals evaluated was extremely high, and the thoughtful effort put into all proposals was evident.

Dear Chairman Ketchel & Chairwoman Jones;

As you are well aware, the region is still feeling the aftermath of the Deepwater Horizon oil spill from both economic and environmental perspectives.

Both the Okaloosa County and Walton County Commissions have shown strong support for the establishment of an estuary program for the Choctawhatchee Bay watershed. In fact, both Commissions directed staff to jointly apply for a \$2 million EPA grant designed to “stand up” an estuary program. Unfortunately, we were not successful in that endeavor but believe that the establishment of the Choctawhatchee Bay Estuary Program is too important an effort to be deterred by this minor setback.

We are convinced that the creation of an estuary program for the Choctawhatchee Bay watershed, modelled after the National Estuary Program, will create a legacy program that will continue to provide positive economic and environmental benefits to our region long after the BP oil spill funds are exhausted.

To that end, the Holmes, Washington, Walton and Okaloosa County Commissions, through an interlocal agreement, have established the Choctawhatchee Bay Estuary Coalition. The Coalition Board of Directors is composed of Commissioners Allen Bush, Clint Erikson, Bill Chapman and Kelly Windes as current Chair of the Coalition. Additionally, Alison McDowell, Director of the Choctawhatchee Basin Alliance also serves as a Director of the Coalition. Finally, Mr. Randall Rowland, with Eglin AFB, serves in an ex officio role on the Coalition Board.

The Coalition is exploring numerous, potential funding sources towards this effort. Walton and Okaloosa Counties are in the unique position to affect their own destinies in this regard. Both counties will receive a Direct Component or “Pot 1” allocation from the Restore Act for the next fifteen years.

The Choctawhatchee Bay Estuary Coalition respectfully asks that your Commission consider reserving 10 percent of your Direct Component funds to be used for the Choctawhatchee Bay Estuary Program. If both Okaloosa and Walton County commit to this, it will provide a sustainable level of funding to allow the program to get up and running and more importantly, give the program the ability to leverage other funding sources so that projects within the watershed can be constructed sooner rather than later.

We can provide you and your staff with additional information, including proposals with detailed budgets, administrative and fiduciary safeguards and transparency plans if you so desire and would be happy to speak with you and your Board members if you so desire.

We look forward to working with you on this critically important issue.

Dear Senator/Representative;

As you are well aware, our region is still feeling the aftermath of the Deepwater Horizon oil spill from both economic and environmental perspectives.

We are convinced that the creation of estuary programs for the Choctawhatchee Bay and Saint Andrew Bay watersheds, modelled after the National Estuary Program, will create legacy programs that will continue to provide positive economic and environmental benefits to our region long after the BP oil spill funds are exhausted.

An estuary program is a locally-driven, non-regulatory program that would work to improve the waters, habitats, living resources and economies of both watersheds. In Okaloosa, Walton, Washington, Holmes, Bay, Gulf, Jackson and Dixie Counties, water quality in the bays and watersheds are critical components of our economies. The estuary programs would eventually complete projects throughout these watersheds. Projects would include, but are not limited to: storm water improvements, restoration initiatives, and dirt road paving.

Recently, Holmes, Washington, Walton and Okaloosa Counties, via an Interlocal agreement, formed the Choctawhatchee Bay Estuary Coalition. The Coalition Board of Directors is composed of Commissioners Allen Bush, Clint Erikson, Bill Chapman and myself as current Chair of the Coalition. Additionally, Alison McDowell, Director of the Choctawhatchee Basin Alliance also serves as a Director of the Coalition. Finally, Mr. Randall Rowland, with Eglin AFB, serves in an ex officio role on the Coalition Board.

Additionally, Bay and Gulf Counties have partnered with Florida State University to establish a management group consisting of stakeholders that will direct the operations of the St. Andrew/St. Joe Bays estuary program.

Both estuary programs have management structures and are ready and eager to get started and only lack for funding.

To that end, we respectfully request that you and your colleagues sponsor an appropriations bill for \$4 million to create estuary programs for both the Choctawhatchee Bay and St. Andrew Bay watersheds. This “startup” funding will allow these two estuary programs to more effectively leverage other funding sources (NRDA, Restore, NFWF and Triumph) that will enable the construction of projects throughout the watersheds sooner rather than later. We can provide you and your staff with additional information, including proposals with detailed budgets, administrative and fiduciary safeguards and transparency plans if you so desire.

We look forward to working with you on this critically important issue.

3           Choctawhatchee Bay Estuary Program; providing an

6   Be It Enacted by the Legislature of the State of Florida:

8           Section 1. Choctawhatchee Bay Estuary Program is an  
9 Appropriations Project as defined in The Rules of The Florida  
10 House of Representatives and is described in Appropriations  
11 Project Request 1132, herein incorporated by reference.

12           Section 2. For fiscal year 2017-2018 the nonrecurring sum  
13 of \$2,000,000 from the General Revenue Fund is appropriated to  
14 the Department of Environmental Protection to fund the  
15 Choctawhatchee Bay Estuary Program as described in  
16 Appropriations Project Request 1132. Notwithstanding any law to  
17 the contrary, there shall be no recurring funding provided for  
18 this Appropriations Project.

19           Section 3. This act shall take effect July 1, 2017.
