Walton Beach, Florida, will hold a public meeting to discuss the County's proposal to construct approximately 5.0 miles of new force main and pump station upgrades to the East County Sewer Conveyance System using Okaloosa County Water and Sewer Department (OCWS) staff and equipment. The purpose of the public meeting is to consider whether it is in the public's best interest to perform the project using the local government's own services, employees, and equipment. The scope of work generally consists of: 4.0 miles of 16" pvc & ductile iron pipe, new wastewater pumps and controls, erosion control fixtures, associated piping appurtenances and testing. Approximately 1.0 mile of 18" directional bores will be contracted out. The estimated material estimate including directional boring for the project using OCWS staff is \$1,200,000.
