MAINTENANCE AGREEMENT

THIS AGREEMENT, made and entered into on this 20 day of April, 2000, by and between the STATE OF FLORIDA DEPARTMENT OF TRANSPORTATION (hereinafter called "DEPARTMENT"), and the COUNTY of OKALOOSA, Florida (hereinafter called "COUNTY");

WITNESSETH:

WHEREAS, the DEPARTMENT is preparing to undertake a project within the COUNTY identified and known to the parties by Financial Project I.D. 403798-1-32-01 which will be of benefit to the COUNTY; and

WHEREAS, approval of federal aid necessary to the project requires agreement by the COUNTY to maintain the project;

NOW, THEREFORE, in consideration of the premises, the parties hereby agree as follows:

1. The DEPARTMENT will undertake the project and obtain approval of the Federal Highway Administration for federal participation.
2. Upon completion and acceptance, the COUNTY will assume responsibility for maintenance of the project and will conduct such maintenance in accordance with approved state standards.
3. COUNTY shall indemnify, defend, and hold harmless the DEPARTMENT and all of its officers, agents, and employees from any claim, loss, damage, cost, charge, or expense arising out of any act, error, omission or negligent act by COUNTY, its agents, or employees, during the performance of the Agreement, except that neither COUNTY, its agents, or its employees will be liable under this paragraph for any claim, loss, damage, cost, charge, or expense arising out of any act, error, omission, or negligent act by the DEPARTMENT or any of its officers, agents, or employees during the performance of the Agreement.

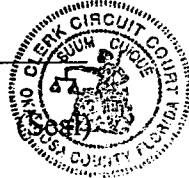
