## INTERLOCAL AGREEMENT

**THIS AGREEMENT** made and entered into this 14<sup>TH</sup> day of December, 1998, by and between the City of Crestview, Florida, a political subdivision of the State of Florida, hereinafter referred to as "CITY", and Okaloosa County, a political subdivision of the State of Florida, hereinafter referred to as "COUNTY", both of which understand and agree as follows:

WHEREAS, the parties hereto have the common power to approve and enforce subdivision regulation development and the recordation of plats pursuant to Chapter 177, F.S., within their geographic jurisdictions; and

WHEREAS, the CITY desires to contract with the COUNTY for new requirements imposed by Chapter 177, F.S. which mandates review and attestation of all plats by a professional surveyor/mapper on CITY staff or under contract to the CITY in addition to the professional surveyor/mapper by the developer of the plat; and

WHEREAS, the CITY does not have a professional surveyor/mapper on staff to accomplish this new unfunded mandate pertaining to subdivision plats; and

WHEREAS, the COUNTY is agreeable to providing these services under the terms and conditions hereinafter set forth.

### WITNESSETH:

The purpose of this agreement is for the COUNTY to provide the following services to the CITY in the manner hereinafter set forth:

1. The COUNTY will provide, through the Okaloosa County Public Works Department, Engineering Division, a review and attestation of subdivision plats pursuant to Chapter 177, F.S. originating within the CITY'S jurisdiction.

2. The CITY is designated as the party to administer this agreement by and through the Administrative Services Department of the CITY and the Okaloosa County Manager or his designee.

3. The CITY shall make payment on demand to the COUNTY in the amount of \$35.00 per hour for performing the services called for herein. Further, a stipulation is made to the COUNTY that allows for an annual adjustment to the hourly rate (if necessary) based upon the cost of services.

4. The COUNTY, it's officers and employees shall not be deemed to assume any liability or responsibility to the CITY or any third party for errors, omissions or mistakes made as a result of the review set forth in Chapter 177, F.S.

5. This Agreement shall become effective on the date the instrument is authenticated by both parties and shall run for a period of one (1) year and may be subject to automatic renewal of one (1) year increments unless either party chooses to terminate the service by written notice within 30 days of the renewal date.
