At 3:00 pm, Thursday, July 25, 2013 (local time), the bids will be opened and read aloud. All bids must be in sealed envelopes reflecting on the outside thereof the bidder's name and EGLIN AIR FORCE BASE ARFF DEVELOPMENT to be opened at 3:00 pm, Thursday, July 25, 2013 (local time). The Board of County Commissioners will consider all bids properly submitted at its scheduled Bid Opening in the Conference & Training Room #305 located at 302 N. Wilson St, Crestview, FL 32536. Bids may be submitted in the Conference & Training Room #305 prior to Bid Opening or delivered to the Clerk of Circuit Court, 302 N. Wilson St., #203, Crestview, FL 32536.

The project consists of all labor, materials, machinery, tools, equipment and other means of construction necessary and incidental to the completion of the work shown on the plans and described in these specifications including, but not necessarily limited to the following: Construction of an approximately 8,600 sf fire station with associated vehicular pavements and site improvements.
